ORDER :

In compliance with the directives issued by the Hon'ble Supreme Court of India, under Article 142 of the Constitution of India, in Writ Petition (Civil) No.350 of 1993 in the matter of Islamic Academy of Education and another Vs. State of Karnataka and others, dated 14-08-2003, "Fee Committee" to determine the fee structure of the Unaided Professional Colleges and in the Unaided Private Teacher Training institutions (B.Ed., and D.T.Ed.), in the Union Territory of Puducherry was constituted vide G.O. referred above.

2. On the recommendation of the Chief Justice of the High Court, Madras, the Lieutenant Governor, Puducherry is pleased to appoint Hon'ble Thiru Justice J.A.K. Sampath Kumar, Judge (Retired), High Court, Madras as Chairman of the said "Fee Committee" from the date of assumption of charge of the said post.

3. The terms and conditions of appointment of the Chairman, Fee Committee are as specified below:

- (a) Term : From the date of assumption of charge of the post to 30-09-2011 or from the date of necessity thereof ceases whichever is earlier
- (b) Pay : Rs.15,000/- per month.
- (c) Accommodation : Free Facility of temporary Government Accommodation In Guest Houses, during sittings.
- (d) Conveyance : A car will be provided during sittings and for the to and Fro journeys between Puducherry and Chennai.
- (e) Pension or Gratuity : The Chairman, Fee Committee shall not be entitled to pension or gratuity for his tenure in the Fee Committee.

4. The terms and conditions of appointment of the Non Official Members :

- (a) Term : From the date of assumption of charge of the post to 30-09-2011 or from the date of necessity thereof ceases whichever is earlier.



- (b) **Sitting Fees** : Rs.300/- per sitting.
- (c) **Travelling Allowances** : TA & DA will be paid as per their entitlement in respect of Government Officials and in respect of other members TA / DA will be paid as applicable to Senior Group "A" Officers.
- (d) **Pension or Gratuity.** : The Non-Official Members are not entitled to pension for gratuity for the period of their tenure in the Fee Committee.

5. The Director of Higher and Technical Education, Puducherry, is declared as the Drawing and Disbursing Officer for the purpose of drawing the term, sitting fee and to meet out other expenses relating to the above mentioned Fee Committee during its tenure. The expenditure on the payment of Term, Accommodation and Conveyance charges to the Chairman shall be debitabie to the Head of Account "2203 - Technical Education - 105 - Polytechnics - 105 (06) - Setting up of Directorate of Technical Education and Higher (Collegiate) Education - 105 (06) (01) Pondicherry Region (28) Professional Services and (11) Domestic TE "PLAN" in the budget.
