### Chapter – 1 Introduction

Democracy requires an informed citizenry and transparency of information which are vital to its functioning and also to restrain corruption and to hold Governments and their instrumentalities accountable to the governed. The revelation of information in actual practice is likely to conflict with other public interests including efficient operations of the Governments, optimum use of limited fiscal resources and the preservation of confidentiality of sensitive information. However, it is necessary to harmonize these conflicting interests while preserving the paramountcy of the democratic ideal. And so it is expedient to provide certain information to citizens who desire to have it.

In view of the above, the Right to Information Act, 2005 (No.22 of 2005) is enacted by the Parliament in the Fifty sixth Year of the Republic of India to provide for setting out the practical regime of right to information for citizens to secure access to information under the control of the public authorities, in order to promote transparency and accountability in the working of every public authority, the constitution of a Central Information Commission and State Information Commissions and for matters connected therewith or incidental thereto.

Consequent on the enactment of the Right to Information Act, the Department of Hindu Religious Institutions publishes this Information Handbook to provide information to citizens regarding matters connected with it. The information available in this handbook is being updated every year with adequate information.

**Chapter – 2 (Manual – 1)**  
**Particulars of Organisation, Functions and Duties**

**Objective:**

*The Department of Hindu Religious Institutions undertakes all earnest steps to ensure that all the temples situated in the Union Territory of Pondicherry, carry out their daily religious activities in accordance with the “Agama” and other common religious principles and thereby guide people in the divine path through daily poojas.*

*The functions of this department are explained one by one hereunder. This department shall be approached for the actions stated therein with regard to religious practices.*

**ADMINISTRATION OF TEMPLE:**

*As per the provisions contained in the Pondicherry Hindu Religious Institutions Act, 1972 and the Rules framed there under, this Department constitutes a Board of Trustees comprising a panel of five members, having term of office for a period of three years, from among the local residents of notable importance in order to promote good administration in temples. As a stop gap arrangement a Government servant is being appointed as Special Officer to temples where good terms for the constitution of Board of Trustees is not prevailing. The Special Officer in addition to his routine duties looks after the administration of the temple purely on honorary basis. Further, renovation committee is being appointed to the temples to undertake renovation upon the request made by the concerned temple authorities.*

**GOVERNMENT GRANT FOR RENOVATION:  
TEMPLES:**

*As per Hindu “Agama” every temple situated in the Union Territory of Pondicherry, has to be renovated once in twelve years in order to refurbish the temple by the conduct of ‘Ashtabanthanam’ and consecration of ‘Kumbabishegam/Samrokshanam’ and thereby enabling people of the vicinity to get the divine blessings bestowed upon them. The Government arranges to provide grant-in-aid for this purpose. Based on the one third matching contribution realized from the public upon the approved plan and estimate and in accordance with the financial position of the Government, two third of the estimated amount is being released as Government grant. The prescribed application form in this regard is given in Annexure-1.*

*One time Financial assistance to the tune of Rs.1,00,000/- is being extended to temples not coming under the purview of this department and situated in Adhi-Dravidar colonies/ economically weaker section areas towards the purchase of building materials for renovation and special repair works.*

**WAKFS/MOSQUES:**

*Similarly, Government Grant-in-aid is being extended to Wakfs/Mosques for renovation and special repair works through the Pondicherry Wakf Board, based on the donations realized from the public and subject to Grant-in-aid rules.*

**GOVERNMENT GRANT FOR ORUKALA POOJA:**

*Government grant @ Rs.5,000/- per annum per temple is being extended to the temples in the Union Territory of Pondicherry having poor resources to meet out the expenses towards the performance of Orukala Pooja. Further, financial assistance @ Rs.500/- and Rs.250/- per annum per temple is being granted to meet out the expenses incurred towards the Current Consumption Charges and Water Consumption Charges respectively. The quantum of aid provisioned under the scheme is projected to be enhanced as Rs.10,000/-, Rs.750/- & Rs.500/- for performance of Oru Kala Pooja, payment of current and water consumption charges respectively during this financial year. The prescribed form is given in Annexure - 2.*

**TRAINING CLASSES IN VEDA/DEVARAM:**

*Training classes in Veda, Devaram and Nalayira Divya Prabantham required for divine worship/poojas are being conducted in Saivaite and Vainavaite temples to the eligible candidates by receiving applications from some of the important temples of Pondicherry region. The application form for this is given in Annexure - 3.*

**FINANCIAL ASSISTANCE TO THE FAMILY OF TEMPLE EMPLOYEES:**

*Under 'Group Insurance Scheme' an amount of Rs.5,000/- and under 'Chief Minister's Welfare Fund' an amount of Rs.20,000/- are being granted to the family of the temple employee who die while in service. The application forms are given in Annexure - 4 & 5.*

## **Chapter - 3 (Manual - 2)** **Powers and Duties of Officers and Employees**

### **The Commissioner**

The Commissioner, invoking the provisions of the PHRI Act, 1972 and the rules framed there under, is administering all the Hindu religious institutions in the U.T. of Pondicherry coming under the purview of the department. The administration of all institutions shall be subject to the general superintendence and control of the Commissioner and such superintendence and control shall include the power to pass any orders, which may be deemed necessary to ensure that such institutions are properly administered and that their income is duly appropriated for the purposes for which they were founded.

The Commissioner in the capacity of Under Secretary (HRI & Wakf) is entitled to issue sanctions of various kinds including those of financial nature. He is the Drawing and Disbursing Officer of this office. All other officers/employees of this public authority are subordinates of the Commissioner and their duties and responsibilities are scheduled/fixed in a manner to ensure smooth administering of the said Act.

### **The Executive Officer (Gr-I)**

The Executive Officer (Temples), Karaikal is exclusively appointed under the provisions of the Act to enable the easy administration of the group of temples in Karaikal region. In addition to the above, administration of all the temples in the Karaikal region are dealt with the superintendence of the Executive Officer (Temples) for administrative convenience and easy manipulation. The Executive Officer is unswervingly responsible to the Commissioner.

**Chapter - 7 (Manual - 6)**  
**Statement of Boards, Council, Committees and other Bodies constituted as its part**

In order to promote good administration in temples under the control of Pondicherry Hindu Religious Institutions Act, 1972 and the Rules framed there under, a Board of Trustees comprising a panel of five members, is constituted from among the local residents of notable importance and the term of office is for a period of three years. As a rule one person belonging to the scheduled caste should be inducted as member of the Board. A Government servant is being appointed as Special Officer to temples as a stopgap arrangement for administrative convenience and pending constitutions of Board of Trustees. The President/Special Officer functions as the head of the religious institutions. The Board meets as often as necessary and in any case at least once in three months for the transaction of the business of the religious institutions. The office of the Board functions in the office/place available within the temple premises. 1. Name of Programme/Scheme : Haj Pilgrimage to Saudi Arabia
2. Duration of the Programme/Scheme : Forty days at Mecca, Saudi Arabia
3. Objective of the Programme : To perform Haj Pilgrimage at Holy Mecca
4. Physical & Financial target of the programme for the last year : 196 Crores by the Government of India
5. Eligibility of Beneficiary : Pilgrims should be Indian citizen with sound health. He should not have performed Haj for the preceding 5 years.
6. Pre-requisites for the benefit : As above
7. Procedure to avail the benefits of the programme : Pilgrim should send prescribed Haj application through the State Haj Committee concerned, to the Haj Committee of India, Mumbai with the proof of residence, medical fitness certificate and the certificate of the Secretary, State Haj Committee along with a demand draft of Rs.10,700/- drawn in favour of State Haj Committee.
8. Criteria for deciding eligibility : All applicants who apply for Haj with the document detailed in column 7 and the eligibility prescribed in column 5 are eligible
9. Details of the benefit given in the programme : Air fare of Rs.24,000/- is given as subsidy for each pilgrim and free medical facility is provided at Mecca.
10. Procedure for the distribution of the subsidy : Subsidy is distributed towards airfare to each and every pilgrim when he applies through State Haj Committee provided he should comply the requisites stipulated in column 5 and 7.
11. Where to apply or whom to contact in the office for applying : Pondicherry Haj Committee
12. Application Fee : Free of cost
13. Other Fees : The Pilgrim shall send payment in the manner of demand draft on three spells  
(a) a demand draft for Rs.10,700/- towards

advance foreign exchange in favour of State Haj Committee.

(b) a demand draft for Rs.61,000/- towards exchange , i.e. food and accommodation at Mecca, Saudi Arabia to be sent to the Haj Committee of India, Mumbai.

(c) a demand draft for Rs.12,000/- towards air fare to be sent to the Haj Committee of India, Mumbai.

The proposals from religious institutions and public petitions are dealt promptly and action in the matter is taken within a week except certain cases, which requires special attention and in any case within a fortnight. Special petitions, cases requiring the decision of the higher authorities, matters in which policy decision to be taken and opinion of the other departments to be sought for and other special cases are dealt with utmost care and action is initiated to dispose them within a month. The matters connected with the grant-in-aid and financial assistance are done on merits of the case, considering the urgency of the proposal, eligibility factor, with notions to have a wide coverage spectrum of areas in the U.T. of Pondicherry, with concentration on the areas of A.D. colonies and economically weaker sections and in adherence to the Agama principles.

**Frequently asked questions and their answers**

- (i) Whom to contact for seeking information?

The office of the Hindu Religious Institutions has two units namely (a) Establishment Unit and (b) Temple Administration Unit. For any verbal information regarding the laid down procedures in matters associated with the said two units, may approach the Manager (Temples) and Executive Officer (Gr-II) respectively for guidance. For any other information connected with this public authority, the public may address their request letters with the gist of the subject on which information is required to the Public Information Officers listed in 'Chapter - 8'.

- (ii) How to join training classes in veda/ devaram?

Training classes in Veda, Devaram and Nalayira Divya Prabantham required for divine worship/poojas are being conducted in Saivaite and Vainavaite temples to the eligible candidates by receiving applications from some of the important temples of Pondicherry region. The application form for this is given in Annexure - 3 of Chapter-2. Interested candidates may apply in the prescribed format to the Commissioner.

- (iii) Collection of temple share.

Temple share is an amount payable by the temples towards cost of appointment/strengthening of administration. Based on the annual income of the temple the department assesses share amount. In order to ensure transcendental governance of the PHRI Act, 1972 by way of strengthening of administration of the Hindu Religious Institutions, temple share is being collected from temples coming under the purview of this department, under the provisions of the Act. ## (iv) How to apply for grant-in-aid/financial assistance provided under various schemes?

The temple authorities that want to receive aid under various schemes of this department may approach the office of the Commissioner and know about the eligibility criteria and then apply in the prescribed forms with required documents.

Sanctioning of aid is subject to the fulfillment of eligibility criteria under appropriate rules and to the fullest contentment of the competent authority.

- (v) What is the fee structure for getting information?

A request for obtaining information under sub-section (1) of section 6 shall be accompanied by an application fee of rupees ten by way of cash against proper receipt or by demand draft or bankers cheque payable to the Commissioner, Hindu Religious Institutions, Pondicherry.

For providing the information under sub-section (1) of section 7, the fee shall be charged by way of cash against proper receipt or by demand draft or bankers cheque payable to the Commissioner, Hindu Religious Institutions, Pondicherry at the following rates:

- (a) Rupees two for each page (in A-4 or A-3 size paper) created or copied;
- (b) Actual charge or cost price of a copy in large size paper;
- (c) Actual cost or price for samples or models;
- (d) For information provided in diskette or floppy rupees fifty per diskette or floppy; and
- (e) For information provided in printed form at the price fixed for such publication or rupees two per page of photocopy for extract from the publication.
