been elaborated in this handbook. Further the budget allocation for the plan schemes is

given in this book. To keep the transparency, various subsidy schemes operated in this

Directorate are detailed in the ensuing chapters.

CHAPTER – 2 Particulars of Organization, Functions and Duties

Objective/purpose of the public authority.

- To promote transparency and speedy administration to the public.
- To uplift the poor and downtrodden by assigning free house site patta
- To help poor landless labourers in constructing pucca house by way of granting housing subsidy
- To give crystal clear status of lands by maintaining centralized Land Records

Main activities/functions of the public authority

- VIII. Transfer of Kudiyiruppu patta under the Pondicherry Occupants of Kudiyiruppu (Conferment of ownership) Act, 1973.
- IX. Transfer of patta under Section 16 of the Pondicherry Settlement Act and Rules. 1970.
- X. Rectification of erroneous entry of land records under Section 23(1) of the Pondicherry Settlement Act, 1970.

<u>SETTLEMENT SECTION – I</u>

A) Government to Citizen

I. TRANSFER OF PATTA (INVOLVING SUB DIVISION)

Modification or inclusion in the approved register of rights by sub-dividing the field.

The applicant should be the owner of the land/manai either by way of purchase/partition/release deed/will deed either by reason of death of any persons or by reason of transfer of interest or by way of any other subsequent change in the holding.

Documents to be produced

- Registered sale deed copy and other documents in proof of ownership right.
- Any other documents proving the ownership right
- Legal heir certificate and
- Previous link documents establishing link with the survey records.

Whom to apply: The application affixed with Court Fee Stamp of 0.75 paise addressed to the Director of Survey in case of Oulgaret and Pondicherry Taluk and to the concerned Tahsildar/Deputy Tahsildar (Specified Officer) of the other Taluks/ Sub-Taluks and sub-division charges of Rs.10/- to be paid.

2. <u>Issue of certified copies of the Settlement extract:</u>

Documents to be produced

Sale deed or other documents proving ownership right

Whom to apply: The application affixed with Court Fee Stamp of 0.75 paise addressed to the Director of Survey and Land Records, Pondicherry and concerned Deputy Collector (Revenue) in case of outlying regions.

III. RECTIFICATION OF ERRONEOUS ENTRY OF LAND RECORDS

Corrections carried out by the Director or Settlement Officer on any bonafide mistake caused due to any clerical or arithmetical mistake or to any decision or proceedings under the Pondicherry Settlement Act.

Original Documents to be produced

- Registered Sale Deed
- Registered Will Deed
- Registered Donation Deed
- Legal heir Certificate to prove the ownership right and any other antecedent earlier link documents.

Whom to apply: The application affixed with Court Fee Stamp of 0.75 paise addressed to the Director of Survey and Land Records, Pondicherry.

4. TRANSFER OF KUDIYIRUPPU PATTA

The applicant should be the legal heir of the Kudiyiruppu pattadar.

Documents to be produced

- Death Certificate of Kudiyiruppu Patta Holder
- Original Kudiyiruppu Patta and
- Legal Heir Certificate

Whom to apply: The application affixed with Court Fee Stamp of 0.75 paise addressed to the Director of Survey and Land Records, Pondicherry and concerned Deputy Collector (Revenue) in case of outlying regions.

5. PROVISION OF HOUSE SITES

<u>Category –I</u>: Assignment of free house sites to the poor landless agricultural labourers by acquiring lands through Land Acquisition – subject to approval of the Advisory Committee.

Category – II: Assignment of free house sites to the encroachers of Govt. land subject to the clearance from the concerned departments having control over the site and approved by the Advisory Committee. (REGULARISATION process).

Category –III: Assignment of free house sites to the encroachers of Govt. manai already assigned under LGR after cancellation of the previous assignment (REASSIGNMENT process).

Eligibility Condition:

should

- be a poor landless labourer.
- be a Indian Citizen with the residence of not less than 5 years in the Union Territory of Pondicherry.
- have a monthly income not exceeding Rs.2000/- per month
- not possess house/land.

Whom to apply: The application in prescribed form or in white paper affixed with Court Fee Stamp of 0.75 paise addressed to the Director of Survey and Land Records, Pondicherry and concerned Deputy Collector (Revenue) in case of outlying regions *viz.*, Karaikal, Mahe and Yanam.

6. <u>GRANT OF HOUSING SUBSIDY TO THE BENEFICIARIES OF FREE HOUSE SITES.</u>

Housing financial assistance of Rs.40,000/- is extended under the Rural House Construction Scheme in three installments @ Rs.10,000/-, Rs.20,000/- and Rs.10,000/- respectively.

Eligibility condition:

The applicant should possess Free House Site Patta assigned by the Directorate of Survey and Land Records.

Whom to apply:

To apply in the prescribed Form No.3. affixed with court fee stamp of Rs.0.75 paise addressed to the Director of Survey and Land Records, Pondicherry and to the concerned Deputy Collector (Revenue), in respect of Karaikal, Mahe and Yanam.

Pattern of assistance:

Release of 1st Instalment: At the time of disbursement of assignment order.

Release of 2nd Instalment: On completion of the construction upto 5 feet from the ground level.

Release of 3rd Instalment: On completion of the construction of the house with RCC roofing.

7. NAME TRANSFER OF FREE HOUSE SITE PATTA ASSIGNED UNDER L.G.R

On the death of the original assignee, free house site patta transferred to the legal heir(s).

Whom to apply: The application affixed with Court Fee Stamp of 0.75 paise addressed to the Director of Survey and Land Records, Pondicherry and concerned Deputy Collector (Revenue) in case of outlying regions.

Doucments to be produced:

- 1. Copy of the original patta.
- 2. Death Certificate of the original assignee.
- 3. Birth Certificate of the petitioner
- 4. No Objection Certificate obtained from other legal heirs.
- 5. First page of Ration Card and Electoral Photo Identity Card are to be enclosed as a mark of residential proof.

8. <u>ISSUE OF DUPLICATE FREE HOUSE SITE PATTA:</u>

Whom to apply: The application affixed with Court Fee Stamp of 0.75 paise addressed to the Director of Survey and Land Records, Pondicherry and concerned Deputy Collector (Revenue) in case of outlying regions. The application should have the following documents:

- 1. Written application clearly describing the cause of loss.
- 2. Any available copy of the patta either xerox or mutilated or damaged one.
- 3. Non-traceable Certificate issued by the Police Officer having jurisdiction.
- 4. Proof for continuous residence in the free house site.
- 5. Certificate issued by the Fire Department for proof of Fire accident.

9. <u>Demarcation (Pointing out of boundaries)</u>

Measurement of new sub-division referred by the Settlement Officer, Directorate of Survey and Land Records, Pondicherry. The charge for survey is Rs.10/- per sub-division.

Pointing- out the Survey boundaries (F line petition). Rs.5/- is collected for each F line.

<u>Whom to apply:</u> Demarcation application affixed with 0.75 paise Court Fee Stamp addressed to the Director of Survey and Land Records in case of Pondicherry and Oulgaret Taluk and to Tahsildar/Deputy Tahsildar of the other Taluk and sub-taluks.

10. FMB Copies:

Certified FMB copies issued on payment of Rs.5/- per division.

Whom to apply: The application should be addressed to the Director of Survey and Land Records, Pondicherry and the concerned Deputy Collector (Revenue) in respect of Karaikal, Mahe and Yanam. Court Fee stamp of Re.0.75 paise should be affixed in the application.

	Assistant Director of Survey	Assistant Director of Survey is the highest Technical post in Directorate of Survey and Land Records. He is responsible for the following functions in the Directorate.
		 He will assist the Director of Survey in all Technical matters. He will monitor the work in Branch Survey offices in the Head Quarter as well as in the outlying regions. He will also monitor the Survey work in Taluk and Sub-Taluk Offices. He will see that sufficient work is assigned to the Survey Staff of various cadres under his control and get the work done smoothly and efficiently in time bound manner. This act gives the powers of Director, Settlement Officer and Specified Officer in respect of the settlement, re-settlement, determination of assessment, reduction, suspension, remission of assessment. This act with the aid of rules made under it gives the procedure for preparing settlement records namely, Settlement Register and Register of Rights. It also gives the manner in which mutation and change of registry need to be dealt with. This act provides for the issue of certified copies to any interested person on payment. More importantly this act gives power to the Director, Settlement Officer and the Collector to correct mistakes in the Revenue records.

This act originally consisted of 31 sections. Presently sections 1 to 14, 24-31 are only in force. This act gives procedure based on which survey of land in the Union Territory of Pondicherry is conducted. It also paves way for the appointment of various classes of Survey Officers and also gives their powers. This act entrust the power to determine and record an undisputed boundaries as well as a disputed boundaries to Survey Officer and also provides for appeal against the order of the Survey Officer. It casts duty upon the registered holder of the land to main the survey marks and enumerates the duty of Village Officers. There is also a provision for the arbitration in respect of any dispute in the boundary of land. In a nut shell this act with the help of rules made under it vividly explains the procedure of survey, powers of Survey Officers, duties of Village Officers, duties of registered holders, etc.,

CHAPTER - 15

Norms set by it for the discharge of its functions

Procedure to be followed for assigning free house site pattas

For assigning Free House Site Patta, the applicant - should

- 1. be a poor landless labourer
- 2. be an Indian Citizen with the residence of not less than 5 years in the Union Territory of Pondicherry.
- 3. have a monthly income not exceeding Rs.2000/- per month.
- 4. not have a house of his own.

The applicant should address to the Director of Survey and Land Records for Pondicherry region and for the outlying regions viz. Karaikal, Mahe and Yanam the concerned Deputy Collector (Revenue) shall be addressed. The application should bear a Court Fee Stamp of 0.75 paise.

Procedure to be followed for sanction under the Rural House Construction scheme

Housing financial assistance of Rs.40,000/- is extended under the Rural House Construction Scheme in three installments @ Rs.10,000/-, Rs.20,000/- and Rs.10,000/- respectively.

Eligibility condition:

The applicant should possess Free House Site Patta assigned by the Directorate of Survey and Land Records.

Whom to apply:

To apply in the prescribed Form No.3. affixed with court fee stamp of Rs.0.75 paise addressed to the Director of Survey and Land Records, Pondicherry and to the concerned Deputy Collector (Revenue), in respect of Karaikal, Mahe and Yanam.

Pattern of assistance:

Release of 1st Instalment: At the time of disbursement of assignment order.

Release of 2nd Instalment: On completion of the construction upto 5 feet from the ground level.

Release of 3rd Instalment: On completion of the house with RCC roofing.

CHAPTER - 16

Information available in an electronic form

- 1. The Settlement Registers of 129 revenue villages have been captured in computerized settlement database. Out of 129, 104 revenue villages patta transfer are done through on-line and patta copy (RoR) being issued to the public through on-line.
