Officials and other employees have been appointed in the Project Implementation Agency Pondicherry and the said society is functioning now. In order to meet out the salaries of all the Officials and other personnel to be employed/engaged by the Project implementation Agency Pondicherry like consultants, experts, technical persons, purchase of office equipments, furniture, computers, provision of telephones, hiring of vehicles etc. sanction of the Lieutenant Governor, Pondicherry is hereby conveyed for the release of Grant-in-aid not exceeding Rs.1,00,00,000/- (Rupees one crore only) for the aforesaid purposes.

The above said assistance will be rendered through the Project Implementation Agency Pondicherry. This grant is for recurring and non-recurring expenditure and is subject to the following conditions:

- a. The grant shall be utilised in a time bound manner.
- b. There is no amount available with the Project Implementation Agency Pondicherry at present.
- c. The Society shall get its account audited from the Chartered Accountant.




