2. Technical Bid:

The Tenderer(s) should upload online the technical specifications (without quoting price) as detailed in Annexure – I along with the following Certificates/Documents as their technical Bid:

- Scanned copy of Registration /Trade Certificate of the applicant's organization;
- Scanned copy of PAN;
- Scanned copies of the IT returns filed for the last 3 (three) financial years (or) scanned copies of Audited balance sheets for last 3 (three) financial years from Registered Chartered Accountant;
- Scanned copy of the Goods & Service Tax registration certificate;
- The Tenderer should submit scanned copies of minimum 3 (three) years of experience in the field of work / supply to the Government Departments;
- The Tenderer may submit documentary evidence in support of appreciation of the relevant work carried out for the different Government departments/ organizations (optional);
- Online payment details of Tender Fee for Rs.500/- and Earnest Money Deposit for Rs.32,837/-
- Scanned copy of Proforma (Annexure – I) duly filled and signed by the authorized signatory.

Note:

- i. The particulars of the Firm / Tenderer should be furnished in the Proforma prescribed in the Annexure-I and duly signed by the authorized person of the Company / Firm. The Annexure-I and the above said documents / certificates shall be scanned and uploaded as a single file (Technical Bid). Failure to produce even any one of the above documents would entail rejection of their quotation. Bids of Tenderers who do not confirm to the criteria stipulated in this document shall be rejected.
- ii. The copies of the Tender documents submitted online should be clear and legible. Otherwise it will not be considered.

3. Price Bid (BOQ):

- a. The Tenderer(s) who have submitted all the above required certificates / documents along with their Technical Bid will alone be considered for evaluation of their Price Bid (BOQ);
- b. The rates quoted in the BOQ should be inclusive of GST / Loading and Unloading / Labour / Transport / Erection and Dismantle / Other Charges;
- c. The rates quoted in the BOQ should be for one unit of each item.

4. Interested and eligible firms / contractors / suppliers who had downloaded the Tender document from the website <https://pudutenders.gov.in> shall submit the same in online using Digital Signature Certificate (DSC) only. The Tenderer should upload the bid document online by verifying the tender assigned work before the scheduled time of submission. No Tender document should be sealed and brought to the office of the Director, Directorate of Information and Publicity, Puducherry.

5. The tenderer(s) should deposit their Tender Fee of Rs.500/- (Rupees Five hundred only) and Earnest Money Deposit (EMD) of Rs.32,837/- (Rupees Thirty two thousand eight hundred thirty seven only) to A/c No.005605013213, IFS Code:ICIC0000056, ICICI Bank, Mission Street Branch, Puducherry through online either Internet Banking or NEFT/RTGS **on or before 05.00 PM on 02/09/2024.** The “**Instructions for online Bid Submission**” is enclosed as Annexure – IV.

The bidders cannot purchase Tender schedules by remitting cash and no pre-request for issue of tender schedules will be entertained.

The bidders shall submit e-tender document fee and EMD on or before the closing date and time of submission of Tender through online ie. either Internet Banking or NEFT/RTGS mode and for which necessary challan will be available in the website. The Office will not be responsible for any delay in the realization both Fees and the bidder who had downloaded the Schedule from the website shall submit the Tender Schedules online before the closing date of tender submission.

6. Terms and Conditions:

- a. The issue of Award of Contract (AOC) / Agreement / Work order will be in unit rates for each of the 19 items in the NIT;
- b. The Earnest Money Deposit (Bid Security) is non-interest bearing and is refundable to the unsuccessful tenderer;
- c. The Earnest Money Deposit (Bid Security) will be refunded to the successful tenderer at the earliest after the satisfactory completion of all contractual obligations after the contract period;
- d. Performance security of 5% of the contract value has to be deposited by the successful Tenderer awarded the contract to ensure due performance of the contract.
- e. Income Tax deductions and GST deductions will be made from total bill amount while making payment;
- f. The provision of materials / supply on hire basis for the above-mentioned work items should be new, good quality and defect-free. Utmost care must be taken while erecting to ensure the safety of the participants;
- g. After the completion of the function, the erected works and arrangements on hire basis should be dismantled and taken back by the service provider at their own cost. The Department of Information and Publicity will not compensate for any loss or damage to the hired materials during the conduct of function or during transit of the materials;
- h. The rates quoted will have to be valid for the contract period and no additional costs for any reason or at any cost shall be charged
- i. In the event of failure to complete the work in time or not according to specification by the selected tenderer or refusal to undertake the work allotted to them either expressly or otherwise, the Bid Security will be forfeited and the work order will be cancelled. Such firm will also be blacklisted for any future supply;
- j. The Department reserves the right to put additional conditions, change of venue based on the prevailing situation / contingency raised that deemed fit;
- k. The successful bidder awarded the contract shall agree and sign an Arbitration agreement (Chapter 8 of NIT) with this Department and that shall form part of the contract / agreement documents;
- l. The Notice Inviting Tender (NIT) shall form part of contract / agreement documents. The Department will not be responsible for any failure, malfunction or breakdown of electronic system used during the e-Tender process.

7. Arbitration

The parties agree that any mutual dispute with regards to terms of this Contract shall be handled through Arbitration, as per the following terms, between them:

(I) THAT, the parties agree that any dispute or difference whatsoever arising between the parties out of/under or in connection with or relating to the construction, meaning, scope, operation, or effect of the contract or the validity or the breach thereof shall be referred to a Sole Arbitrator as appointed under clause (IV) here in below, and that the award made in pursuance thereof shall be binding on the parties;

(II) AND THAT, the parties agree that in respect of those matters, as are not defined in the terms and conditions of the main contract, or in this Arbitration Agreement, the same shall be decided and settled by the Sole Arbitrator in accordance with the Arbitration and Conciliation Act, 1996 and the amendments thereof as in operation on the date of execution of the Contract;

(III) AND THAT, the parties agree that the place of Arbitration shall be at Pondicherry in the Union Territory of Puducherry;

(IV) AND THAT, whenever the parties decide to resort to Arbitration for dispute resolution, the Secretary to the Government of Puducherry (Department of Information & Publicity) shall be the authority to appoint the Sole Arbitrator from amongst a panel of Arbitrators maintained by the Government of Puducherry, and such appointment shall be binding on both the parties: Provided that before requesting the Secretary (Department of Information & Publicity) for appointing an Arbitrator, the parties shall make a sincere attempt to resolve their dispute, within a time period of 3 months, through mutual conciliation, and if so felt necessary by the parties under the supervisory guidance of the Secretary (Department of Information & Publicity);

(V) AND THAT, all costs relating to the Arbitration proceedings, shall be borne equally by both the parties;

(VI) AND THAT, the parties agree that the language for making all submissions and evidence will be presented in ENGLISH during the proceedings;

(VII) AND THAT, it is agreed between the parties that they shall extend their fullest support and co-operation to the Sole Arbitrator and not seek adjournment of the Arbitration proceedings, without explaining the reasons therefor, in writing, in advance, for seeking of such adjournment, and further that there shall not be more than two such adjournments granted, even when there exists a valid reason for seeking such adjournment. And it is further agreed that the parties should cooperate in completing the arbitration process and the broader dispute resolution within 6 months or at most with an extension, on mutual consent, of another 6 months;

(VIII) AND THAT, it is agreed by the parties hereto that, in so far as there is an arbitral award for payment of money, the Sole Arbitrator may include in the sum for which the award is made, interest at the RBI repo rate, as on the date on which the cause of action arose, plus 2%, on the whole, or any part of the money, for the whole or any part of the period, between the date on which the cause of action arose and the date on which the award is made: Provided that, on the sum so directed to be paid by an arbitral award, there shall be no interest payable for three months commencing from the date of award, but thereafter, interest shall be payable at RBI repo rate plus 4% for such period of delay, till the date of payment;

(IX) The Arbitrator shall record, in writing, the arguments of the two parties on each of the points of dispute and pass a speaking order thereon.

8. The Director (Information and Publicity) reserves all rights either to accept or reject the tender without assigning any reason thereof.

ANNEXURE-IV

INSTRUCTIONS FOR ONLINE BID SUBMISSION

1. The bidders are required to submit soft copies of their bids electronically on the Procurement Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the e-Procurement Portal, prepare their bids in accordance with the requirements and submitting their bids online on the e-Procurement Portal.

More information useful for submitting online bids on the e-Procurement Portal may be obtained at: <https://pudutenders.gov.in>

2. REGISTRATION

- i. Bidders are required to enroll on the e-Procurement module of the e-Procurement Portal (UHL: <https://pudutenders.gov.in>) by clicking on the link "Online bidder Enrollment" on the e-Procurement Portal which is free of charge.
- ii. As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- iii. Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the e-Procurement Portal.
- iv. Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class II or Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. nCode, eMudra etc.), with their profile.
- v. Bidder then logs in to the site through the secured log-in by entering their user ID / password and the password of the Digital Signature Certificate.

3. SEARCHING FOR TENDER DOCUMENTS

- i. There are various search options built in the e-Procurement Portal, to facilitate bidders to search active tenders by several parameters. These parameters could include Tender ID, Organization Name, Location, Date, Value, etc.
- ii. Once the bidders have selected the tenders they are interested in, they may download the required documents / tender schedules. These tenders can be moved to the respective 'My Tenders' folder. This would enable the e-Procurement Portal to intimate the bidders through SMS / email in case there is any corrigendum issued to the tender document.
- iii. The bidder should make a note of the unique Tender ID assigned to each tender, in case they want to obtain any clarification / help from the helpdesk.

4. PREPARATION OF BIDS

- i. Bidder should take into account any corrigendum published on the tender document before submitting their bids.
- ii. Please go through the tender document carefully to understand the documents required to be submitted as part of the bid. Please note the number of covers in which the bid documents have to be submitted, the number of documents - including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.
- iii. Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document generally, they can be in PDF format. Bid documents may be

scanned with 100 dpi which helps in reducing size of the scanned document. Maximum size of the bid document shall not exceed 35MB.

5. SUBMISSION OF BIDS

- i. Bidder should log into the site well in advance for bid submission so that they can upload the bid in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other issues
- ii. The bidder has to digitally sign and upload the required bid documents one by one as indicated in the tender document.
- iii. All the documents being submitted by the bidders would be encrypted using PKI encryption techniques to ensure the secrecy of the data. The data entered cannot be viewed by unauthorized persons until the time of bid opening. Confidentiality of the bids is maintained using the Secured Socket Layer(SSL) 128 bit encryption technology. Data storage encryption of sensitive fields is done. Any bid document that is uploaded to the server is subjected to symmetric encryption using a system generated symmetric key. Further this key is subjected to asymmetric encryption using Department's bid openers public keys. Overall, the uploaded tender documents become readable only after the tender opening by the authorized bid openers.
- iv. The uploaded tender documents become readable only after the tender opening by the authorized bid openers.
- v. Upon the successful and timely submission of bids (i.e. after Clicking "Freeze Bid Submission" in the portal), the portal will give a successful bid submission acknowledgement which is downloadable/printable. This acknowledgement may be used as an entry pass for any bid opening meetings.

6. ONLINE PAYMENT OF EMD & TENDER FEES

The bidders have the option to make payment of EMD & Tender fee through the following modes:

- i) Internet Banking
- ii) NEFT/RTGS.

In internet banking, bidders shall make payments using his/her internet Banking enabled account with any of the banks listed in the Annexure enclosed. The payment Gateway will display a list of banks wherein the bidder has to choose his bank. Upon selection, the bidder will be taken to the login page of his/her bank. The bidder has to Login and proceed for paying the Tender fees/EMD. If the transaction is successful, system will be redirected to the e-Tendering portal for submission of bid.

To facilitate bidders who do not have Internet Banking facility, payment can be made offline through NEFT/RTGS mode. In this option, the bidder has to take print-out of the NEFT/RTGS payment Challan auto-generated by the system and visit his/her bank to remit the requisite amount. Once payment is received in the pooling account, the bidders will be able to proceed for bid submission by feeding the Unique Transaction Reference(UTR) number in the e-Procurement portal. It is advised that the bidders make payment one day in advance for validation purpose.

Bid submission can be done immediately when EMD/Tender fee is paid through "Internet Banking" mode when compared to NEFT/RTGS mode of payment.

During evaluation of tender, EMD of unsuccessful bidders will be automatically refunded to the bidder's account from where they initiated payment.
