ORDER:

The Adi Dravidar Welfare Department, Puducherry implements housing scheme to provide financial assistance to Scheduled Caste beneficiaries for Construction of houses of their own under the scheme "Grant of House Construction subsidy to Scheduled Caste and other Economically Backward Classes people". Under the scheme the subsidy amount of Rs.1,00,000/- is granted in 3 instalments at the rate of Rs.40,000/- Rs.30,000/- and Rs.30,000/- respectively as per rules modified vide GO read above.

- 2. The Director has stated that 57 application are in hand and anticipation 45 applications (Total 57+45=102) for 2<sup>nd</sup> and 3<sup>rd</sup> installments under the above said scheme, for which an amount of Rs.30,60,000/--towards grant of 2<sup>nd</sup> and 3<sup>rd</sup> installments of subsidy to the eligible person in respect of Puducherry region.
- 3. Therefore, sanction of the Lieutenant Governor is hereby conveyed to the incurring of an expenditure not exceeding Rs.30,60,000/- (Rupees thirty lakh and sixty thousand only) towards the release of 2<sup>nd</sup> and 3<sup>rd</sup> installment respectively to the eligible person as per rules in force in respect of Puducherry Region as detailed below:-

- 4. The Director, Adi Dravidar Welfare Department shall ensure thast (i) the terms and conditions specified in the Housing Secretariat's G.O. Ms.No.6/91/F6 dated 14/03/1991 are satisfied and (ii) that persons once benefited under this scheme are not again considered for this purpose, before making payment to the beneficiaries selected.
- 5. In respect of Puducherry region, all payments to be made to beneficiaries be made by electronic fund transfer to the respective accounts of beneficiaries as per Circular NO.1822/FS(PA)/2011 dated 23/09/2011 of the Secretary to Government (Finance).

- 6. The list of beneficiaries shall be furnished by the Director, Adi Dravidar Welfare Department, while preferring the claim to the Director of Accounts and Treasuries, Puducherry.
- 7. The expenditure sanctioned in para 3 above shall be debitable to the following head of account: "2225 Welfare of Scheduled Castes, Scheduled Tribes and Other Backward Classes 01-Welfare of Scheduled Castes 01/789 Special Component Plan for Scheduled Castes 01/789(28) Construction of Low Cost dwelling Units development of housing colonies/house sites and Grant of House Construction Subsidies" 01/789 (28) (01) Puducherry region (33) Subsidies Plan in the Vote on Account 2014-15.
