AMENDMENT

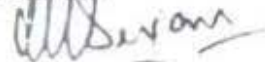
In the said rules:

- (ii) In Form No. VI prescribed under rule 5(5) for the words, figures and brackets "Rs.25,000/- (Rupees twenty five thousand only)", the words, figures and brackets "Rs.50,000/- (Rupees fifty thousand)" shall be substituted.
