2. The Committee shall perform the following functions:

- (a) Review the progress of the schemes for the Welfare of the Scheduled Castes evaluate their impact and suggest measures for further improvement.
- (b) Review the implementation of protection of Civil Rights Act and suggest measures for its proper enforcement.
- (c) Review the Implementation of reservation orders in the service under the Pondicherry Administration including Government undertakings. Boards Co-operatives, Municipalities etc., and suggest measures for further improving the representation of Scheduled Castes.
- (d) Review the Implementation of Scheduled Caste Sub-Plan and suggest measures for further improvement.
- (e) Make on "On the Spot Study" of the situation, if need be in cases of atrocities on Scheduled Castes or in cases, where harassment of Scheduled Castes has to be reported.
- (f) Discuss any other matter which affects the rights and interests of persons belonging to Scheduled Castes and suggest appropriate measures.

3. The Heads of Department and other instrumentalities of the Government viz., Labour Commissioner, Register of Co-operative Societies, Superintending Engineer, Electricity Department, Project Director, District Rural Development Agency, Director of Industries, Director of Agriculture, Director of Animal Husbandry, Director of Health and Family Welfare, Director of Civil Supplies and Consumer Affairs, Director of School Education, Director of Technical Higher Education, Director of Social Welfare, Director of Women & Child Welfare Department, Sub/Dy. Collector Revenue (North) and Sub/Dy. Collector Revenue (South) Puducherry and the Director, National Commission for Scheduled Caste, Chennai, shall be invited as special invitees to the meeting with a view to get their co-operation in the matters pertaining to their departments in the implementation of various development programmes for the Welfare of Scheduled Castes.

4. The Committee shall meet ordinarily twice in a year.

5. The character and antecedent of the non-official members have been verified and their term shall be for a period upto 30<sup>th</sup> June, 2021. The term of the M.Ps/MLAs. shall be for a period upto which they shall continue to be the Members of Parliament/Legislative Assembly.
