ORDER:

The Adi Dravidar Welfare Department, Puducherry implements housing scheme to provide financial assistance to Scheduled Caste beneficiaries for Construction of houses of their own under the scheme "Bharat Ratna Rajiv Gandhi Housing Scheme to the homeless Scheduled Caste and Economically Backward Classes people". Under the scheme the subsidy amount of Rs.4,00,000/- is granted in 3 instalments at the rate of Rs.1,50,000/- each as 1st & 2nd instalments, Rs.50,000/- in the form of Cash transfer and Rs.1,00,000/- as building materials and the 3rd instalment at the rate of Rs.1.00.000/- as Cash transfer subject to fulfillment of conditions stipulated in the scheme. Accordingly, the expenditure sanction accorded during the 2013-14 as detailed below. The Director, Adi Dravidar Welfare Department has stated that the sanctioned amount, of Rs.746.60 lakhs in respect of Puducherry is fully utilized by the Adi Dravidar Welfare Department, Puducherry.

- 1. Puducherry Region (543 beneficiaries) 1st & 2nd installment Rs. 7, 46, 60, 000/-
- 2. Karaikal Region (335 beneficiaries) 1st & 2nd installment Rs.5,02,50,000/-3. Yanam Region (51 beneficiaries) 1st installment - Rs. 76,50,000/-

Now, the Director, Adi Dravidar Welfare Department, Puducherry has sought for expenditure sanction for Rs.1,87,50,000/- towards grant of 2nd installment of house construction subsidy under this scheme

for Puducherry region for 2014-15 as detailed below.

- 2. Therefore, sanction of the Lieutenant Governor is hereby conveyed to the incurring of an expenditure not exceeding Rs.1,87,50,000/- (Rupees one crore eighty seven lakhs and fifty thousand only) towards the release of 2nd installment of Housing subsidy under 4.00 lakhs subsidy to 125 No (25+100) Scheduled Caste/ Other Economically Backward Class People in Puducherry Region under Bharat Rathna Rajiv Gandhi Housing scheme for the year 2014-15.
- 3. The Director, Adi Dravidar Welfare Department shall ensure that (i) the terms and conditions specified in the Housing Secretariat's G.O. MS.No.6/91/F6 dated 14.3.1991 are satisfied and (ii) that persons once benefited under this scheme are not again considered for this purpose, before making payment to the beneficiaries selected.
- 4. The Director of Adi Dravidar Welfare shall publish in the official website and in the notice board of the department the list of beneficiaries with relevant details before release of each installment of the subsidy.
- Adi Dravidar Welfare Department shall release Rs.50,000/- being the one third of first instalment (1/3 x Rs.1,50,000/-) of House Construction Subsidy through ECS to the beneficiaries in Puducherry region as per Circular No.1822/FS(PA)/2011 dated 23.09.2011 of the Finance Department, Puducherry. The Department shall release the remaining two third of first instalment i.e. Rs.1,00,000/- (2/3 x Rs.1,50,000/-) directly to the Puducherry Co-operative Building Centre, Puducherry in turn the society shall supply building materials to the beneficiaries in puducherry region. In respect of Karaikal and Yanam regions usual procedures should be followed. The 1st & 2nd instalment should be released after fulfill the conditions stipulated at para 2 (b) of the G.O.Ms.No.3/2012/Wel(SCW), dated 20.03.2012.
- 6. The list of beneficiaries shall be furnished by the Director, Adi Dravidar Welfare Department, while preferring the claim to the Director of Accounts and Treasuries, Puducherry.
- 7. The expenditure sanctioned in para 3 above shall be debitable to the following head of account: "2225 Welfare of Scheduled Castes, Scheduled Tribes and Other Backward Classes 01-Welfare of Scheduled Castes 01/789 Special Component Plan for Scheduled Castes 01/789(28) Construction of Low Cost dwelling Units development of housing colonies/house sites and Grant of House Construction Subsidies" 01/789 (28) (01) Puducherry region (33) Subsidies Plan in the Vote on Account 2014-15.
