## ORDER:

The Adi Dravidar Welfare Department, Puducherry implements a housing scheme to provide financial assistance to scheduled caste beneficiaries for construction of houses of their own under the name "Bharat Ratna Rajiv Gandhi Housing Scheme to the homeless Scheduled Caste and Other Economically Backward Classes people". Under this scheme the subsidy amount of Rs.2.00 lakh is granted in three instalment viz., 1<sup>st</sup> instalment Rs.50,000/- in cash, 2<sup>nd</sup> instalment of Rs.1,00,000/- in the form of building materials and the 3<sup>rd</sup> and final instalment of Rs.50,000/- in cash to the eligible person by the department, after getting sanction from the Government. Expenditure Sanction during 2013-14 for Rs.2,78,50,000/- has been sanctioned towards release of 2<sup>nd</sup> and 3<sup>rd</sup> instalment of housing subsidy vide G.O.Rt.No.37 dt.07.10.2013 2<sup>nd</sup> cited for Puducherry, Karaikal and Yanam regions. Now, the Director, Adi Dravidar Welfare Department has sought for a block expenditure sanction for Rs.95,00,000/- in respect of Puducherry Region to grant 3<sup>rd</sup> installment of subsidy to the eligible person as per rules in force for the year 2014-15.

- 2. Therefore, sanction of the Lieutenant Governor is hereby conveyed to the incurring of an expenditure not exceeding Rs.95,00,000/- (Rupees ninety five lakh only) towards release of 3<sup>rd</sup> instalment of House construction subsidy to the eligible SC/OEBC people in Puducherry region as per the rate prescribed in the rules under the subsidy amount of Rs.2.00 lakhs.
- 3. The Director, Adi Dravidar Welfare Department shall ensure that (i) the terms and conditions specified in the Housing Secretariat's G.O.MS.No.6/91/F6 dated 14.03.1991 are satisfied and (ii) that persons once benefited under this scheme are not again considered for this purpose, before making payment to the beneficiaries selected.
- 4. The Director of Adi Dravidar Welfare shall publish in the official website and in the notice board of the department the list of beneficiaries with relevant details before release of each installment of the subsidy.
- 5. In respect of Puducherry, all payments to be made to beneficiaries by electronic fund transfer to the respective accounts of beneficiaries as per circular No.1822/FS(PA)/2011 dated, 23.09.2011 of the Secretary to Government (Finance).
- 6. The list of beneficiaries shall be furnished by the Director, Adi Dravidar Welfare Department, Puducherry as the case may be while preferring the claim to the Directorate of Accounts and Treasuries, Puducherry.
- 7. The expenditure shall be debited to the head of account: "2225 –Welfare of Scheduled Castes, Scheduled Tribes and Other Backward Classes-01-Welfare of Scheduled Castes –01/789-Special Component Plan for Scheduled Castes-01/789 (28) (01) Construction of low cost Dwelling units Development of housing colonies/house sites and Grant of House construction subsidies 01/789(28)(01) Puducherry region 33 Subsidies Plan" in the vote on account 2014-15.
- 8. This issues with the concurrence of the Finance Department, Puducherry vide their U.O. No.1968/F5/A2, dated 27.08.2014.
