Ms. No. 7/AWD/G7/2014, dated 10.02.2014, sanction is hereby accorded to incur an amount not exceeding **Rs.1,24,50,000/-** (Rupees One crore twenty four lakhs and fifty thousand only) towards grant of **1<sup>st</sup> installment of House Construction Subsidy to 83 persons @ Rs. 1,50,000/- each** (Rs.50,000/- by electronic fund transfer system to the accounts of the beneficiaries and Rs.1,00,000/- in the form of building materials through the Pondicherry Co-operative Building Centre) out of Rs.4.00 Lakhs entitled under the Scheme " Bharat Rathna Rajiv Gandhi Housing Scheme" for **reconstruction of damaged houses** to the Beneficiaries who were allotted low cost dwelling units and who availed subsidy of Rs.6,000/- Rs.10,000/- and Rs.20,000/- in respect of Puducherry region for the year **2015 -16** as detailed in the annexure.

2. It is also certified that the above amount is within the Block Sanction obtained as per orders cited and the conditions specified in the G.O 2<sup>nd</sup> cited has been followed.
