ORDER:

The Department of Adidraavidar Welfare releases Grants-in-Aid to PADCO to provide civic amenities in Scheduled Caste colonies in Puducherry region. Based on the proposal supported with the detailed estimate and plans received from the PADCO, Puducherry, for the following 17 Nos. of works relating to provision of civic amenities in Embalam Constituency costing Rs.3,32,62,000/-, the Director, ADW has sought for expenditure sanction to release grants-in-aid to the above said Corporation.

2. Therefore, sanction of the Lieutenant Governor is hereby conveyed for incurring of an expenditure not exceeding Rs.3,32,62,000/- (Rupees three crores thirty two lakhs and sixty two thousand only) towards release of Grant-in-Aid to the PADCO, Puducherry to carry out the following works relating to provision of civic amenities.

3. This grants for recurring / non-recurring expenditure and is subject to the following conditions:

- i. The grants shall be utilized in a time bound manner.
- ii. The unspent balance of the previous grants has to be taken into account.
- iii. The Society/Institution/Corporation shall get its accounts audited from Chartered Accounts.
- iv. The accounts of the Society/Institution/Corporation shall be open to inspection by the sanctioning Authority and audit of the Directorate of Accounts and Accountant General.
- v. The Society/Institution/Corporation shall maintain subsidiary accounts of the Government grants as required under GFR 210.
- vi. A certificate of actual utilization shall be furnished in accordance with GFR 212 (1).
- vii. Annual Reports of the Society/Institution/Corporation shall be submitted to the Government.
- viii. The Annual accounts of the grant receiving Society/Institution/Corporation should be completed within 6 month of the end of the financial year.
- ix. The pattern of assistance is in accordance with Rule 20 of the Delegation of Financial Powers Rule, 1978.
- x. The terms and conditions prescribed in G.O.Ms.No.47/79-HEW (HW) dated 16.3.1979 shall be followed while executing the work by the PADCO, Puducherry.

4. The expenditure shall be debitable to the Head of Account: "2225-Welfare of Scheduled Castes, Scheduled Tribes and Other Backward Classes - 01- Welfare of Scheduled Caste - 01/789-Special Component Plan for Scheduled Castes - 01/789 (27) Providing Civic & Basic Amenities to the areas of Scheduled Caste -01/789(27)(01) Puducherry Region (31) Grant-in-aid "Plan" in the budget of the current financial year 2015-16.

5. The Department/PADCO shall ensure that there is no duplication of above works execution by other Government Department/Agencies.

6. The Department will upload the pre and post construction photographs of the proposed works on their official website.
