- (i) at least meet twice in a calendar year, in the month of January and July for transacting its business;
- (ii) review the implementation of the provisions of the Act and Rules.

 discrimination;



- (iii) assess the relief and rehabilitation facilities provided to the victims and other matters connected therewith;
- (iv) monitor the prosecution of cases under the Act;
- (v) oversee the role of different officers / agencies responsible for implementing the provisions of the Act;
- (vi) evaluate the various reports received by the Government and other matters connected therewith and after examining such reports the Committee shall take steps to implement the recommendations made in the reports.
