The following notification shall be published in the next issue of the Official Gazette.

NOTIFICATION

In pursuance of rule 9 readwith rule 2(g) of the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Rules, 1995, and in supersession of the Notification issued vide G.O.Ms.No.09/2014-Wel(SCW), dated 07.03.2014 of the Secretariat(Adi Dravidar Welfare), Puducherry. and published vide Gazette No.11, dated 18.03.2014, save as respects things done or omitted to be done before such supersession, the Hon'ble Lieutenant-Governor, Puducherry is hereby pleased to nominate Tmt.R. Alice vaz, IAS., Secretary to Government(Welfare) as the Nodal Officer for the purpose of the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989 (Central Act 33 of 1989) and read with the said rules for the whole of the Union Territory of Puducherry and she shall discharge the functions as the Nodal Officer for implementing the provisions of the said Act and the rules.

2. The Nodal Officer designated above under the said Act and the rules shall apart from the powers and functions required to be exercised and discharged under the said Act. She shall also perform the following functions for the implementation of the said Act and the rules, namely:-

- (i) The Nodal Officer should coordinate the functioning of the District Magistrates and Superintendent of Police or other authorized officers, Investigating Officers and other officers responsible for implementing the provisions of the said Act.
- (ii) The Nodal Officer should collect information and furnish it for the purpose of preparation of the Annual Report on the Protection of Civil Rights Act, 1955 and the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989.
- (iii) Review the reports received under the sub-rule (2) and (4) of rule 4, rule 6, clause (xi) of sub-rule (1) of rule 8 by the end of every quarter
- (iv) Review the position of the cases registered under the Act
- (v) Review the Law and Order situation in the identified area
- (vi) Review the various kinds of measures adopted for providing immediate relief in cash or kind or both to the victims of atrocity of his or her dependent.

- (vii) Review the adequacy of immediate facilities like rationing, clothing, shelter, legal aid, travelling allowance, daily allowance and transport facilities provided to the victims of atrocity or his/her dependents
- (viii) Review the performance of Non-Governmental Organisations, the Scheduled Castes and Scheduled Tribes Protection Cell, various committees and the public servants responsible for implementing the provisions of the Act.
