ORDER:

The Directorate of School Education has proposed to purchase Laptop and distributed to the Higher Secondary success students from the Academic year 2013-14 in the Union Territory of Puducherry under scheme of "Free distribution of Laptop Higher Secondary success students". The Department of School Education finalized around 6111 students eligible for grant of Laptops including 1232 Nos. of Scheduled Caste students (Puducherry-939 + Karaikal - 293) studying in the Government school of this Union Territory. The Department School Education has sought for funds for an amount of Rs.2,46,40,000/- estimated towards purchase of Laptops for Scheduled Caste students from Adi-Dravidar Welfare Department Head of Account. Accordingly, the Director, Adi-Dravidar Welfare Department had sought for expenditure sanction for Rs.1,66,00,000/- based on the fund availability in their department for depositing with the Department of School Education under Head of Account "8443-Civil Deposit-800-Other Deposits, which could then be drawn and paid to the Department School Education as per normal procedure of withdrawal under deposits", which will utilized towards purchase of Laptop for free distribution to XII Std. Scheduled Caste students who had passed in 2013-14 through Department School Education Puducherry. The balance amount of Rs.80,40,000/- will be released to the Department of School Education in the next financial year 2015.16.

2. Accordingly, sanction of Lieutenant Governor of Puducherry is hereby accorded for release of an amount of Rs.1,66,00,000/- (Rupees One crore sixty six lakes only) to Department of School Education as deposit utilized towards of purchase of Laptops to be distributed to the Scheduled Caste students studying in the Government school of Union Territory of Puducherry who had passed Higher Secondary from Academic year 2013-14.
