2. The above Committee shall perform the duties and responsibilities as provided under the Scheduled Castes and the Scheduled Tribes (Prevention of Atrocities) Act, 1989 (Central Act 33 of 1989) and the rules framed thereunder and further the Committee shall:-

- (i) meet at least twice in a calendar year, in the month of January and July for transacting its business.
- (ii) review the implementation of the provisions of the Act and Rules, wherever implementation is found not adequate it shall ensure that the Act and Rules are strictly implemented without any discrimination.
- (iii) assess the relief and rehabilitation facilities provided to the victims and other matters connected therewith.
- (iv) monitor the prosecution of cases under the Act.
- (v) oversee the role of different officers/agencies responsible for implementing the provisions of the Act.
- (vi) evaluate the various reports received by the Government and other matters connected therewith and after examining such reports the Committee shall take steps to implement the recommendations made in the reports.
