#### TERMS AND CONDITIONS FOR SUPPLY OF SIX WEEK OLD TURKEY POULTS 2024-25

- 1. Turkey breeders/poultry breeding farmers/distributors of poultry and turkey shall quote for the supply of six week old turkey poults. A certificate from a local Government Animal Husbandry Authority not below the rank of Veterinary Assistant Surgeon of the area be furnished with the tender that the participant of this tender is any of the said category (Turkey breeders/Poultry breeding farmers/Distributors of poultry or turkey). Please place a scanned copy of the Veterinary certificate as a technical document.
- 2. The rates quoted should be inclusive of cost of packing, forwarding charges, taxes etc. The supply should be on door delivery basis to various institutions of the Department in Puducherry and Karaikal at the own risk of the supplier at the convenient dates acceptable to the institutions.
- 3. The supplier must specify the regions to which they intend to supply, turkey poults and quote the rates accordingly, otherwise it will be construed that the rates quoted are applicable to all region.
- 4. The rates quoted should be for 1 number of 6 week aged turkey poults & valid for one year from the date of opening of Financial bid/'B' -cover. The rate must be quoted in BOQ only ('B' -cover only). Any documents showing rate in 'A' cover will not be accepted.
- 5. The Bidders should submit their Quotation **online only** at the Government website **pudutenders.gov.in** and should make their own arrangement in obtaining the **Digital Signature Certificate**.
- 6. The rates quoted must be only in the Bill of Quantities (BOQ) format in the 'B' cover/price Bid.
- 7. The rates shall be quoted only if the specification furnished by this Department are tallied with the item proposed to be supplied.
- 8. The rates should be typed in the BOQ (price list) as whole rupee and paisa only for each region separately. **No special characters should be typed.**

Earnest Money Deposit (EMD):

9. A sum of Rs.1,20,000/- (Rupees One lakh and eighteen thousand only) for Puducherry region and Rs.48,000/- (Rupees fifty thousand only) for Karaikal region has to be paid through the ICICI payment gateway as Earnest Money Deposit. (Refer instruction to Bidders in puducherry.gov.in website). No exemption of EMD is allowed for any reason. EMD will be refunded to the unsuccessful bidder. No interest will be paid on the Earnest Money Deposit.

Security Deposit:

- 10. The successful vendor should remit a Security Deposit at 5% on total value of the tender. Only on receipt of the Security Deposit the supply order would be placed. The Government will pay no interest for any deposits made by the vendor. The Security Deposit will be refunded after satisfactory completion of the supplies. The Performance Security shall be furnished in any of the form of an Account payee Demand Draft, Fixed Deposit receipt from a commercial Bank or Bank Guarantee from a commercial bank in favour of the Drawing and Disbursing Officer, Department of Animal Husbandry and Animal Welfare, Puducherry.
- 11. A supplier blacklisted for any reason thereof by the Department of Animal Husbandry and Animal Welfare, Puducherry or by any other Central/State Government Organisation will not be allowed to participate in the tender.
- 12. The accepted vendor should sign an agreement in the format given by the department.
- 13. Payment will be made against delivery basis.

#### CONDITIONS FOR THE SUPPLY OF TURKEY POULTS

- 14. The vendor must be in a position to supply the Turkey poults in convenient batches after receiving supply orders with prior intimation to this Department and to the regional consignee concerned.
- 15. The batch size of turkey poults supplied must be a minimum of 200 birds. The vendor may also specify the maximum size of batch he could supply.
- 16. The turkey poults should be healthy and vaccinated against diseases (RD.F/L at first week), a certificate of vaccination given to the birds be furnished along with every batch of supply.
- 17. The turkey poults supplied must be not less than six week old and must weigh a minimum live body weight of 900 grams.
- 18. The turkey poults must be delivered to the respective places specified in batches at the expenses of the vendor, at convenient intervals with the consent of the department with advance intimation. In case of any default in the supply as specified or deviation of condition of supply, the turkey poults will be returned at the cost of the vendor.
- 19. Approximate number of turkey poults proposed to be purchased and the delivery places are mentioned below:
