Terms and Conditions

e-Tender for the supply of 20,000 litres of Liquid Nitrogen for the year 2025-2026 are invited from the Manufacturers / Marketing Agencies.

1. The rate quoted should be F.O.R. – Frozen Semen Bank, Key Village Centre, Department of Animal Husbandry and Animal Welfare, Puducherry.
2. **Taxes, if any, may be quoted separately.**
3. The Liquid Nitrogen should be supplied at convenient intervals as required by the Department and the bill will be settled for each such supplies.
5. The Tenderer should give an assurance that the Liquid Nitrogen will be supplied as and when the department makes indent to supply, since the Liquid Nitrogen is very essential item used in this department for the preservation of Frozen Semen straws. Hence, the company should make necessary arrangements to supply the Liquid Nitrogen without any interruption.
6. The Tenderer should ensure purity and quality of the Liquid Nitrogen supplied and should produce the required certificate from competent authorities in this regard. In case the material supplied is found to be not of the required quality, the tenderer has to take back the whole supply and replace it with quality product at his cost. Failure to comply with these conditions will cause cancellation of the Quotation and the supplier will be liable to compensate for the resultant loss to the Government of Puducherry.
7. **The rates quoted must be valid for a period of one year from the date fixed for opening the tender.**
