No.13/79/HEW (AW) dated 31.01.1979 as amended from time to time, sanction is hereby accorded for the drawl of an amount of **Rs.10,50,000/- (Rupees Ten lakhs fifty thousand Only)** towards grant of incentive award to **21** Inter Caste Married couples at the rate of **Rs.50,000/-** each under the Non-Plan scheme of "Grant of Incentive award to Inter-Caste married couples", for the year 2015-16 as detailed in the annexure.

2. The beneficiaries mentioned in the Annexure satisfy the eligibility condition prescribed under the scheme "Grant of incentive award to inter-caste married couple".

3. The amount shall be drawn by the Drawing & Disbursing Officer, Adi-Dravidar Welfare Department, Puducherry and disbursed to the applicant concerned after obtained proper acquittance.
