ORDER

Sub: AWD – Grant of Financial assistance for taking “Prolonged Treatment” by the Poor SC patients (**Fresh**) belonging to Pondicherry Region for the year 2014-15 – Orders – Issued.

In pursuance of the Government Orders cited, sanction is hereby accorded to incur an amount not exceeding **Rs.1,12,484/-** (Rupees one Lakh Twelve Thousand four hundred and eighty four Only) towards grant of financial assistance to **14** SC patients who are suffering from prolonged diseases at the rate of Rs.500/- each per month for the period as noted against each under the scheme “Grant of financial assistance to poor SC people who are suffering from Prolonged Disease” as detailed in the annexure.

2. It is certified that the beneficiaries are eligible for availing the assistance as per the conditions stipulated under the “Government of Pondicherry, Grant of financial assistance to SC patients suffering from Prolonged Diseases Rules, 2001.” The Medical Board, Puducherry have certified that the individual mentioned in the annexure are unable to work and requires Prolonged Treatment vide reference 3rd cited above. The amount sanctioned above does not exceed that the Block Expenditure Sanction obtained Vide G.O.2nd cited.

3. The amount shall be disbursed after getting proper acquittance from the beneficiaries concerned

4. The expenditure is debitable to the head of account “2225 – Welfare of SC / ST and OBCs -01 – Welfare of Scheduled Castes 01/789 – Special Component Plan for SCs 01/789 (25) Welfare measures to uplift to SC people 01/789(25)(01) Puducherry Region - 50 - Other Charges – Plan” in the Vote on account 2014-15.
