Sealed tenders are invited for disposal of old condemned and unserviceable Television Sets (e-waste) from the authorised e-waste collection centre/recycler/ dismantler in Puducherry in "as-is-where-is" condition as below:-

The sealed tenders should be addressed to "The Block Development Office, Villianur, Puducherry - 605 110 " duly super scribing on the envelope as "Tender for purchase of E-Waste items" and should reach this office on or before 5.00 pm on **11.08.2026**. The tenders will be opened on **13.08.2026** at 11.00 am in the presence of the tenderers or their representatives who are present at that time if any, in the chamber of the Block Development Officer, Villianur. If the opening day of the tenders happens to be a public holiday, the same will be opened on the next working day.

3. The tender will be awarded to the highest tenderer.

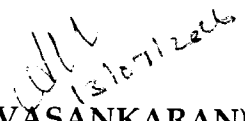
4. Tender received after the due date and time will be rejected. If the highest tender amount offered by the tenderer is found to be not acceptable by the undersigned, then open auction will be conducted on the spot keeping the highest tender amount as the minimum upset price for bid of auction, the tenderers who have already submitted sealed tender will only be allowed.

5. The intending tenderers (Puducherry Pollution Control Committee authorized e-waste recyclers) shall deposit an Earnest Money Deposit of Rs.500/- (Rupees Five hundred only) along with sealed tenders. The EMD of the unsuccessful tenderers will be refunded after finalization of the tender.

6. The successful tenderer /bidder shall pay the entire amount immediately along with the prevailing GST, and clear all the items within 24 hours at their own risk and arrangements, failing which the Earnest Money Deposit (EMD) will be forfeited and remitted into the Government Account. The office will not in any way held responsible for the safe custody or any loss of the sold articles. No claim on the quantity and quality of the materials will be entertained.

7. The intending tenderers can inspect the condemned and unserviceable Television Sets (e-waste) from 10.00 am to 12:00 noon on any working day on or before 07.08.2026 at this office with the permission of the undersigned.
8. The tenderer or his authorized representative who bears the authorization letter only will be admitted at the time of opening the tenders / auction process.
9. Along with the sealed tender, a copy of all the following self-attested documents should be submitted by the tenderer.
 - a) ID Card of the authorized person of Company/Firm.
 - b) Valid GST Certificate.
 - c) Copy of authorization/registration issued by the Central Pollution Control Board for recycling.
10. Individuals / Partner of a firm who have been punished under CrPC/JIPC/BNS/BNSS or any criminal case under process, is not eligible for participating in the tender-cum-auction. If any false representation is found during the tender process, the tender offered by them/ him will be cancelled and their / his EMD will be forfeited.
11. If, any participant(s) misbehaves during the tender / auction process, the tenderer(s) will be removed from the place of auction and also his /their tender(s) will be rejected and the EMD will be forfeited.
12. The undersigned reserves the right to accept or reject any or all tenders without assigning any reason thereof and the decision of the undersigned in this regard will be final and binding on all the tenders. If, the tender / auction date falls in a holiday, the tender/auction sale will be held on the next working day.
