Government of India, Ministry of Home Affairs notified the Rules of Business of the Government of Puducherry, 1963 on 22.06.1963 vide first read above and an amendment was substituted by them on 12.11.1973. It inter-alia deals with Administrator's executive functions, disposal of Business allocated among Ministers / Executives, matters for which reference is to be made to Government of India, etc.

During the last 50 years, the Union Territory of Puducherry has witnessed growth and development in various fields and many Schemes are implemented for the development of the people of Union Territory of Puducherry. However aspirations of the people have also risen manifold and there are many areas which need attention of the Government and many sectors whose potential for contribution to growth of Puducherry's economy is untapped. Rules of Business provides the framework for the Government to function. Many provisions in the Rules of Business of Government of Puducherry need suitable enhancement / revision keeping with the present day cost of index/pay scale, etc. so as to meet the genuine aspirations of the common citizen effectively and speedily.

3. Therefore, the Lieutenant Governor, Puducherry is pleased to constitute a Committee with the following composition to examine and recommend suitable amendments in the Rules of Business of Government of Puducherry wherever necessary:-
