NOTIFICATION

In exercise of the powers conferred by clause (a) of sub-section (1) of section 16 of the Consumer Protection Act, 1986 (Central Act No.68 of 1986), read with the Notification S.O.No.469(E), dated 15th May, 1987 of the Government of India and in consultation with the Hon'ble Acting Chief Justice of High Court of Judicature at Madras, the Lieutenant-Governor, Puducherry, hereby appoints the Hon'ble Justice Thiru. K. Mohanram (Retired) holding office as Chairman of the State Level Commission for the Backward Classes at Puducherry to hold full additional charge of the post of the President of the State Consumer Disputes Redressal Commission at Puducherry for purposes of the said Act vide Notification issued under G.O.Ms.No.15, dated 11th May, 1988 of the Civil Supplies Department, Puducherry and published in the Official Gazette No.39, dated 27th September, 1988 vice the Hon'ble Thiru. K. Raviraja Pandian, Judge (Retired) resigned.

2. The appointment shall be on part-time basis from the date of assumption of charge until regular arrangement is made:

Provided that in case regular arrangement could not be made from the date of issue of this Notification until 27th May, 2017 for any reason, this Notification shall not be valid beyond 27th May, 2017.
