**NOTIFICATION**

In exercise of the powers conferred by clause (a) of sub-section (1) of Section 16 of the Consumer Protection Act, 1986 (No.68 of 1986) read with Government of India's notification in S.O.No.469(E), dated 15<sup>th</sup> May 1987 and Rule 4(1) of Pondicherry Consumer Protection Rule, 2018 and in consultation with the Hon'ble Chief Justice of High Court of Judicature at Madras, her Excellency the Lieutenant-Governor of Puducherry hereby appoints **Hon'ble Selvi Justice R. Mala, Judge (Retired), High Court, Madras** as the President of the State Consumer Disputes Redressal Commission constituted for the purpose of the said ACT vide Notification issued under G.O.Ms.No.15 dated 11<sup>th</sup> May, 1988 of the Civil Supplies Department, Puducherry and Published in the Official Gazette No.39 dated 27<sup>th</sup> September, 1988.

2. The appointment shall be for a period of 5 years from the date of assumption of charge or upto the date on which the Hon'ble Justice attains the age of 67 years, whichever is earlier. Separate orders will be issued regarding her service conditions.
