Sub: Filling up of the post of Dean, RIVER, Puducherry by deputation basis – Regarding.

I am directed to state that it is proposed to fill up one post of Dean (Group "A") in Rajiv Gandhi Institute of Veterinary and Research, Kurumbapet, Puducherry by deputation in the Pay Level of 14 (Pre-revised Pay Band of Rs.37,400 - 67,000 with the AGP of Rs.10,000/- + NPA applicable).

The eligibility criteria are as follows:

- i) The Officers of Central / State / Union Territory Governments / Universities / Recognized Research Institutions / Public Undertakings;
 - a) Who are holding analogous posts on regular basis (or) with 3 years regular service in posts in Pay Level of 14 (Pre-revised Pay Band of Rs.37,400 – 67,000 with the AGP of Rs.9,000/- or equivalent; and
 - b) Possessing the qualifications and experience, as detailed below:
 - i) A Masters Degree in Veterinary and Animal Services with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) of a recognized University.
 - ii) Ph.D Degree in any branch of Veterinary and Animal Sciences.
 - iii) Associate Professor / Professor with a total experience of 15 years of Teaching / Research / Administration in Veterinary Universities / Colleges and other Institutions of higher education.
 - iv) Registration with Central / State Veterinary Council.
(Period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central / State / Union Territory Governments shall ordinarily not exceed 5 years. The maximum age limit for appointment by deputation shall be "not exceeding 56 years" on the closing date of receipt of applications)

2. The period of tenure will be 3 (three) years only from the date of joining and may be extended for an another period of one year after due approval from the Board of Governors, PVCS and after obtaining approval from the Government of Puducherry or the date of superannuation, whichever is earlier.

3. Candidates may download the prescribed application from the Government website (i) www.py.gov.in (ii) recruitment.puducherry.gov.in and (iii) www.ragacovas.com and apply in the said format along with the requisite copies of certificates and other testimonials through proper channel with No Objection Certificate. Otherwise, the applications will not be considered. Applications should reach the Deputy Secretary to Government (AH), Chief Secretariat, Puducherry 605 001 latest by **5.30 p.m. on 07.02.2022.**

4. I am to point out that the officer once selected shall not be allowed to withdraw or refuse to join and it shall be responsibility of the sponsoring authority to release the selected officer within one month from the date of issue of the appointment order.

5. It is requested that the post may kindly be given wide publicity to Veterinary and Animal Science Universities / Colleges / Research Institute / Govt. Autonomous Organizations under your control.
