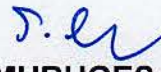

In exercise of the powers conferred vide reference 2nd cited, sanction of the Secretary to the Govt.(Fisheries) is hereby conveyed to incur an expenditure not exceeding to **Rs. 2,15,639/- (Rupees Two lakhs fifteen thousand six hundred and thirty nine only)** towards grant of 75% subsidy on the annual insurance premium paid by 27 numbers of registered mechanized fishing boat owners of Pondicherry region for insuring their boats against marine risks, as detailed in the Annexure for the year 2022-23 (as phase-III), under the Scheme "Development of Marine Fisheries through Mechanization and Reimbursement of Sales Tax on HSD oil and Assistance to Small Scale Fishermen".

2. Permission is also accorded to release an amount of **Rs. 2,15,639/- (Rupees Two lakhs fifteen thousand six hundred and thirty nine only)** directly to the beneficiaries' saving bank A/cs by way of ECS mode.

3. The expenditure is debitable to the Head of Account, "2405-Fisheries-103 Marine Fisheries- 103 (05) - Development of Marine Fisheries through Mechanization and Reimbursement of Sales Tax on HSD oil and Assistance to Small Scale Fishermen – 103 (05) (01) - Pondicherry region (33) - Subsidies" in the Revised Estimate of the financial year 2022-23.
