ORDER:

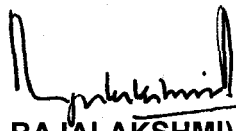

With a view, to streamline the procedure for consideration of applications seeking land use conversion, the Lieutenant-Governor, Puducherry is pleased to order that the applications for land use conversion outside the Comprehensive Development Plan area shall also be considered by the Town and Country Planning Department and disposed off by the Town and Country Planning Board based on the recommendations of the Committee / site clearance issued by Town and Country Planning Department, as the case may be.
