NOTIFICATION

The Ministry of Finance, Department of Revenue, Government of India has framed the National e-Governance Plan (NeGP), and the Commercial Taxes Mission Mode Program (hereinafter referred to as the CTMMP) for modernising indirect tax administration and the CTMMP scheme envisages e-services supported by Information Technology for providing improved service delivery through computerisation of commercial taxes to all stake holders and one of the targeted services is introduction of e-payment of commercial taxes.

2. The Ministry of Finance, Department of Revenue, Government of India, New Delhi have also issued guidelines vide Letter No.F.31/12/2008-SO(ST), dated 17th March, 2010 for providing e-payment of taxes, at least through five Public Sector Banks in each of the States/Union Territories and the Reserve Bank of India has also agreed to grant necessary accreditation for the public sector banks specified by the Government for receiving tax revenues to be credited to the consolidated fund of the respective Government, vide their Letter No. DGBA.GAD.No.H-10069/31.5.2001/2009-10, dated 23rd June, 2010.

3. In exercise of the powers conferred by rule 67 of the Puducherry Value Added Tax Rules, 2007 read with section 9 of the Central Sales Tax Act, 1956 (Central Act 74 of 1956) and in pursuance of clause (e) of section 2 of the Information Technology Act, 2000 (Central Act 21 of 2000) read with rule 2 of the Consolidated Fund of the Union Territory of Puducherry Rules, 1963, the Lieutenant-Governor is pleased to direct under rule 26 of the Central Government Account (Receipts and Payment) Rules, 1983 that the tax revenue, fees and any other amount to be paid to the Commercial Taxes Department of the Union territory of Puducherry shall be paid by e-payment mode through the State Bank of India and its branches and through public sector banks who are authorised to collect the Government revenue. The e-payment mode can be opted by any person or any dealer or class of dealers in relation to any business instead of making payment through the instruments prescribed under the Central Government Account (Receipts and Payment) Rules, 1983 and make payment of the Government revenue as described above through the e-Challan, e-Scroll and e-Receipt prescribed in the annexure enclosed.
