This Department proposes to purchase vaccines for Livestock and pet animals against infectious diseases. Hence, you are requested to furnish the rates of different kinds of Livestock and pet animal vaccines manufactured by your firm.

The rates quoted must be only in the Annexure (price list) format supplied by the Department (in duplicate). All columns must be filled without blank. The rates may be quoted only if the specification and packing furnished by this Department are tallied with the vaccine proposed to be supplied and readily available for supply throughout the current financial year.

The rates quoted must be **FOR Destination** with proper cold chain.

## **TERMS & CONDITIONS:-**

- Vaccine supplied should conform to the pharmacopeia's standard authorized by the 1. Government.
- The Details of the vaccine in respect to usage such as dosage, storage, indications, contra-2. indication, route of administration, potency and safety must be given in the form of printed literature for each vaccine.
- Quality assurance must be given by the manufacturer, in addition supporting documents like 3. WHO, G.M.P. certificate if available may be attached for consideration.
- The rates quoted must be F.O.R. Destination Puducherry and Karaikal and must be inclusive of 4. all charges, admissible tax payable by the Govt. only will be paid. Revision of rates will not be allowed under any circumstances.
- Rates must be furnished only in the prescribed proforma (one original + one photocopy), all 5. column of the proforma must be legibly typed. The brand names if any must be shown separately.

- 6. Attested copies of relevant license for the products quoted issued under Drug and Cosmetic Act must be furnished. The Product quoted by the Government firm must be legibly marked in the Drug license. For items not covered under Drug License, a proof of composition details must be furnished as samples, labels showing composition of ingredients and manufacturing license issued by the competent authority.
- 7. The rates quoted must be valid till for one year from the date of opening of quotation.
- 8. The mode of transport and cold-chain method to be adopted must be furnished.
- The vaccine supplied must possess a minimum shelf life of six months from the date of supply.
   Vaccine quoted with longer shelf life will be preferred.
- 10. If authorization is given to any dealer the details must be furnished in the quotation stating that the supplier is in a position to fulfill all the conditions mentioned for the supply.
- 11. Your quotation must be addressed to the Director, Department of Animal Husbandry and Animal Welfare, Puducherry with a superscription on the envelope as "Quotation for the supply of Livestock and pet animal vaccines from Government of India firms CVMS due on 24.3.19...." and the same should reach the undersigned on or before 24.3.19... (5.30 p.m.) The quotations will be opened on 27.3.19... (10.00 a.m.)
