Applications are invited from the eligible candidates who are residents of Puducherry for filling up the post of Junior Scientific Officer in Drugs Testing Laboratory on contractual basis for a period of six months under the Centrally Sponsored Scheme "Strengthening of State Drugs Regulatory System". The details of Educational qualification, age limit, Selection, other condition and application format are mentioned below:-

2. **Eligibility Conditions**:

Experience:- 18 months in Drugs testing and Standardization and research.

3. **Other conditions:**

- a. Contractual recruitment will be made for 6 months from the date of engagement and based on the performance/necessity, the contract will be extended.
- b. The age for the post of Junior Scientific Officer should not exceed 35 years from the date notification issued for the contractual appointment. **Experience in other fields will be rejected**.
- c. The persons engaged on contract basis have no right to claim for permanent or regular employment in this Administration as this is purely a temporary contractual engagement for a specific tenure period and will remain valid upto which the engagement is approved on each occasion.
- d. The persons engaged on contract basis are expected to conform to the rules of Conduct and Discipline as applicable to the Government employees. The persons engaged on contract basis should not have been convicted by any court of Law and shall not any adverse character or antecedents.

- e. Last date for receiving the application is 27.03.2024 till 5 p.m. (on all working days from 10 a.m. to 5 p.m.).
- f. The shortlisted candidates would be called for personal interview, the date and venue of the interview will be intimated later through e-mail only. The shortlisted candidate will have to appear before the Recruitment Committee along with original certificates i.e birth, educational, residence, Nationality/Nativity, community certificate and experience certificate for necessary verification. Candidates have to bear the cost of transport and logistics etc.
- g. The Department reserves the right to cancel/postpone the recruitment if so required. No claim will be admissible in case of such cancellation/postponement.
- h. Candidates from other states/Union Territories are not eligible to apply for the post.
- i. The decision of the Competent Authority regarding selection of candidates will be final and no representation will be entrained in this regard.
- j. The selected employees shall attend the training program to be conducted CDSCO, MoH&FW, New Delhi and others.
- k. Applications incomplete in any aspect will be summarily rejected.
- 1. Change of address, if any, after submission of application should be intimated to the Department or otherwise the Department is not responsible for any postal delay/non delivery of letters etc.
- m. The claims of the candidates with regard to the date of birth, educational, experience, community, nativity and residence are accepted only on the information furnished by them in their application without physical verification of their claims. Their candidature therefore will be provisional at all stages and this Department has the right to reject any candidature at any stage, even after the selection has been made.
- n. The waitlisted candidates shall also be utilized against the requirement in other scheme for Drugs Testing Laboratory in future as and when necessity arises during the next two years.

4. Method of Selection

- i. 50% weightage for marks obtained in Master Degree.
- ii. 0-20% weightage for experience in Drugs Testing Laboratory and Standardization and Research.
- iii. 0-30% weightage for personal interview on subject related to Drugs Analysis method under Drugs and Cosmetics Act 1940 and Rules made thereunder, NABL accreditation and field of experience submitted by the candidates.
