#### **NOTIFICATION**

The Department of Health & Family Welfare Services, Puducherry in the advertisement No.A.12020/1/2013/E4/DHFWS dated 17.05.2013 have notified 11 vacancies (UR-7, MBC-2, OBC-1, SC-1) for recruitment of the eligible candidates to the post of Plumber (Group 'C') carrying the Pay Band 1 of Rs.5200-20200 plus Grade Pay of Rs.1900 fixing the last date for receipt of filled in application on 21.06.2013. In the advertisement it has been mentioned that the candidates who have already applied in response to the advertisement No.A.12020/3/2005/E4/DHFWS dated 12.08.2005 should also apply again as the method of recruitment has been changed and they will be considered for age relaxation in the event of selection subject to obtaining of approval from the Competent Authority.

In the Recruitment Committee meeting held on 10.02.2014, the following eleven candidates have been provisionally selected for the post of Plumber, in the order of merit in their respective categories based on the 50% of marks in SSLC / Matriculation or its equivalent and 50% of marks in the trade of Plumber / Fitter. A deduction of 5% of marks for every additional attempt in the requisite educational / technical qualification(s) shall be made. In addition to the above, 1.5 marks per every completed year of seniority from the date of registration of requisite educational or technical qualification in the Employment Exchange to the last date of receipt of duly filed in application will be added, subject to a maximum of 15 Thus the qualifying marks have been calculated to the maximum total marks of 115 (50+50+15).
