ORDER:

The following Notification shall be published in the Official Gazette:-

NOTIFICATION

As per Section 11A of the Press and Registration of Books Act, 1867, all the Publishers/Printers of the Newspapers/Periodicals are required to submit two copies of their publications regularly at free of cost to the officers prescribed by the Notification issued by the Government. While submitting their Newspapers/Periodicals, it is required to submit their RNI certificate in the first instance in order to maintain a full record of the Newspapers/Periodicals published in the Union Territory of Puducherry. After submitting the copies of the Newspapers/Periodicals of their publication in duplicate, they can get an acknowledgement from the nominated Officer.

2. If the Newspapers/Periodicals have not submitted their editions/publications successively as indicated below to the nominated officer, then it is treated that they have discontinued their edition/publication and the advertisements/facilities/benefits extended by the Information and Publicity Department in respect of those defaulted Media shall be withdrawn without any notice:

a) Dailies - 7 issues successively
b) Weeklies - 4 issues successively
c) Fortnightlies - 3 issues successively
d) Monthlies - 2 issues successively.
