NOTIFICATION

The Government of Puducherry has operationalised the CSC scheme from 11/02/2013 under National e-Governance Plan (NeGP), Now the Directorate of Survey and Land Records has computerized the Land Records in the Union Territory under a project called NILAMAGAL and has been issuing computerized extracts of Land Records/Register of Rights(RoR) viz.Patta/Settlement copy. Now it has been proposed to issue online Patta copy and Settlement extract in respect of lands in the Revenue Villages comprised in the Taluks of Puducherry, Oulgaret, Villianur and Bahour through the Common Services Centres (CSCs) established by this administration. The Services pertaining to Karaikal District, Mahe and Yanam regions will be delivered through the CSCs as and when it is ready.

2. The Department fee and User Charges for issue of Patta/Settlement Copy online through the Common Services Centres and the apportionment of user charges among the stake holders are indicated as below:

- 3. The Directorate of Information Technology, Puducherry may revise the User Charges from time to time. The user charges shall be applicable for every district in the U.T of Puducherry uniformly. A citizen can avail any of the G2C services as included in the CSC scheme, from any CSC, along with all requisite documents and pay the requisite fee/ user charges as detailed in this G.O. The VLE/ SCA shall be responsible for delivery of the online services to the citizen.
