NOTIFICATION

The Government of Puducherry has operationalised the CSC scheme under National e-Governance Plan (NeGP). Now the Directorate of Survey and Land Records has digitized cadastral map(FMBs) of the Union Territory and has been supplying the same to the needy on payment of prescribed fee. Now it has been proposed to issue FMBs in respect of lands of all the Revenue Villages comprised in the Taluks of Union Territory of Puducherry through the Common Services Centres (CSCs) established by this administration.

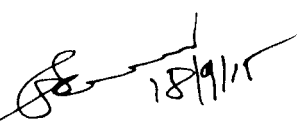
2. The Department fee and User Charges for issue of FMBs through the Common Services Centres and the apportionment of user charges among the stake holders are indicated below:

3. The Directorate of Information Technology, Puducherry may revise the User Charges from time to time. The user charges shall be applicable for every district in the U.T of Puducherry uniformly. A citizen can avail any of the G2C services as included in the CSC scheme, from any CSC, along with all requisite documents and pay the requisite statutory fee and user charges as detailed in this G.O. The Village Level Entrepreneur/ Common Services Centre-Special Purpose Vehicle(CSC-SPV) created under Department of Electronics & Information Technology(DeitY), Ministry of Communications & Information Technology, Govt. of India, shall be responsible for delivery of the online services to the citizen.
