- READ: 1. G.O.Ms.No.97 dated 26.11.2012 of Confidential Cabinet Department, Puducherry.
 - 2. Assumption of charge, dated 09.12.2012 from the Thiru A. Bakthavachalam, Special Representative, Government of Puducherry, New Delhi.

ORDER:

In pursuance to the Government Order first cited, Thiru A. Bakthavachalam has assumed charge as Special Representative for Government of Puducherry at New Delhi with effect from forenoon of 09.12.2012. He shall act as a medium for exchange of information and liase between the Government of Puducherry and the Government of India in completing the tasks of Government of Puducherry. His term of appointment will coincide with that of XIII Assembly or till the necessity therefore ceases whichever is earlier.

- 2. The terms and conditions of the aforesaid appointment will be as follows:-
 - (i) He will have the status of the Minister of Union Territory of Puducherry.
 - (ii) He will be paid a honorarium of ₹ 15,000/- p.m.
 - (iii) His office will be located at the Assembly Complex, Puducherry and his camp office will be at Puducherry Government Guest House, New Delhi.
 - (iv) He will liaise between the Union Territory and the Centre. He will also represent the Union Territory Ministers in the meetings held in New Delhi, if any Minister is unable to participate in such meeting and communicate the views of the Union Territory Government.
 - (v) He will be permitted to draw Travelling Allowance & Daily Allowance on par with Group 'A' Officer of the highest grade (serving in connection with the Union Territory of Puducherry) for journeys performed in connection with the Government of Puducherry and for his halt at New Delhi. He may commute between New Delhi and Puducherry as and when necessity arises.
 - (vi) He shall engage one Stenographer, One Personal Clerk and two Peons on Co-terminus basis and payment made on par with Daily Rated Staff of this Administration. However, due to the functioning of Offices both at Puducherry and New Delhi (camp office) they shall be stationed at Puducherry. While at New Delhi Secretarial Assistance will be provided by the Puducherry Government Guest House, New Delhi.

- (vii) He shall be provided with conveyance by the authorities of Office of the Council of Ministers at Puducherry and by the authorities of Puducherry Government Guest House, New Delhi during his stay at New Delhi.
- (viii) The expenditure incurred towards his honorarium / Travelling Allowances & Daily Allowances / payment to Co-terminus employment will be met from the Budget of the Office of the Council of Ministers, Puducherry.
- (ix) His appointment is terminable on one month's notice on either side.
