ORDER:

Orders have been issued vide G.O. second read above specifying that the Secretaries to Government in this Administration shall henceforth be the Head of Department for the purpose of exercising the powers and function as Disciplinary Authority in respect of Group 'B' posts carrying the Grade Pay upto ₹ 4,600/-, so as to impose all the penalties in terms of Rule 11 of the CCS (CCA) Rules, 1965. The Appellate Authority shall be the President of India in respect of all Group 'B' and Group 'A' posts.

Consequently, in partial modification of the orders issued vide G.O. first read above, the Lieutenant Governor is pleased to constitute the "Review Committee" to review the suspension cases of Group 'B' Officers / officials upto the Grade Pay upto ₹ 4,600/- in respect of whom Secretary to Government is the Disciplinary Authority, as specified below:-
