4. The engagement will be on full time basis initially for a period of six months from the date of engagement and consultancy fee will be paid as per the rules in force. The other terms and conditions of the agreement shall be in accordance with the I.D Note/Memo No. 46324/FD/F3/2014 dated 11.09.2014 of the Finance Department, Puducherry. On selection, the official shall execute an agreement in the prescribed form. The engagement of consultant shall be purely on temporary nature against the specific post and the engagement will be cancelled at any time without assigning any reasons thereof.
