## PRESS RELEASE

The Socio Economic and Caste Census (SECC), 2011 is being carried out by the Government of India to generate information on a large number of social and economic indicators relating to households across the country. This census will enable to rank the households based on their socioeconomic status, so that State/Union Territory Governments can objectively prepare a list of families living below the poverty line in rural and urban areas. It will also help to target the government schemes to the right beneficiaries, and ensure that all eligible beneficiaries are covered, while all ineligible beneficiaries are excluded. Households identified as highly deprived will have the highest inclusion priority under Government welfare schemes

- 2. In Puducherry U.T. Socio Economic and Caste Census 2011 was commenced on 18.07.2011. The enumeration work was completed on 04.10.2011. The data so collected has been processed to present it in the form of a draft list which will contain all the information of the households **except caste**, **religion and chronic disease**.
- 3. The draft list containing information on educational qualification, occupation, income etc., (except caste and health status) on every household elicited during the enumeration process will be published for public view on 1<sup>st</sup> December 2014 and displayed in the following places:

Office of the Deputy Collector (Revenue) –North /South Taluk Offices and Prominent places decided by the Charge Officers

4. The charge officers will appoint Ward Level Officers to receive claims and objections. The ward level officers will be available in the location chosen by the charge officers. Application forms in prescribed format for filing objections, inclusions, modification etc., will be available with these officers free of cost. The Forms can also be downloaded from the NIC Website. Typed /photocopied/cyclostyled forms can also be used. Any person or household who / which wants to include, modify, raise objection on the inclusion of any household / person shall submit an application in the prescribed format to the ward level officers.

- a) Claims & Objections shall be submitted by the public in the prescribed forms only
- b) The claimant / objector shall compulsorily sign or put thumb impression at appropriate place in the form
- c) Claims and objections shall be limited only to the facts displayed in the draft list.
- d) Claims and Objections can be submitted to the designated Ward Level Officer in person or can be sent by post within the prescribed time period.
- e) Claimant or Objector may also support claims with documentary evidence. It is optional at the time of submitting forms.
- f) No application for claim or objection received after 21.12.2014 will be accepted.
- g) Claims and objections presented in <u>BULK</u> by any <u>individual/organization or political</u> party will be refused to be accepted.

Form A – for use of *public* for filing objections against inclusion.

Form B is -for use of *public* for corrections/ modifications of his/her family particulars

Form C is for the inclusion of those households who were omitted/ away from usual place of residence at the time of enumeration

The Ward Level Officers shall receive the claims and objection forms. The filled in forms should reach the Ward Level Officers before 21.12.2014. The details of Ward Level Officers can be obtained from the Charge officers detailed below.
