Sub: Environment – Filling up of the post of Senior Environmental Engineer Group 'A' –Gazetted (Non-Ministerial) in the Department of Science, Technology & Environment, Puducherry.

It is proposed to fill up the post of Senior Environmental Engineer (Group 'A' Gazetted – Non-Ministerial) in the Department of Science, Technology & Environment, Puducherry in Level -11 in the Pay Matrix on deputation basis (including short term contract) from among the eligible Officers serving under the Central Government / State Governments / Union Territories / Recognized Research Institutions / Universities / Public Sector Undertakings/Semi-Government/Statutory or Autonomous Organisations:

- A) (i) Holding analogous posts on regular basis in the parent cadre / Department; or
 - (ii) with 5 years service rendered after appointment thereto on regular basis in posts in Level-10 in the Pay Matrix or equivalent; or
 - (iii) with 6 years service rendered after appointment thereto on regular basis in posts in Level-8 in the Pay Matrix or equivalent; or
 - (iv) with 7 years service rendered after appointment thereto on a regular basis in posts in Level-7 in the Pay Matrix or equivalent, and
- (B) possessing the Educational qualifications and experience as below:

Essential:

i) Masters Degree in Environmental Engineering / Technology or Chemical Engineering from a recognized University with 2 years experience in Environmental Quality Management and Pollution Control activities.

Bachelors Degree in Environmental Engineering / Technology or Chemical Engineering from a recognized University with 5 years of experience in Environmental Quality Management and Pollution Control activities.

[The Departmental Environmental Engineer in Level-7, in the Pay Matrix with 7 years regular service rendered in the grade after appointment on a regular basis and having the educational qualifications as above will also be considered along with the outsiders. If the departmental candidate is selected for appointment to the post, the post shall be treated as having been filled by promotion]

Note 1: Period of deputation (ISTC) including the period of deputation (ISTC) in another ex-cadre post held immediately preceding this appointment in the same or some other organization or departments of the Central / State / Union Territory Governments shall ordinarily not exceed 4 years. The maximum age limit for appointment by deputation shall be not exceeding 56 years as on the closing date of receipt of applications.

Note 2: The Departmental Officer in the feeder grade who are in direct line of Promotion will not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by
