The undersigned is directed to refer to this Department's O.M. of even No. dated 2<sup>nd</sup> May, 2013 revising the Dearness Allowance in respect of employees of Central Government and Central Autonomous Bodies who continue to draw their pay and allowances in the pre-revised scales of pay as per 5th Central Pay Commission.

- 2. The rates of Dearness Allowance admissible to the above categories of employees of Central Government and Central Autonomous bodies shall be enhanced from the existing rate of 166% to 183% w.e.f. 1.7.2013. All other conditions as laid down in the O.M.of even number dated 3rd October, 2008 will continue to apply.
- The contents of this Office Memorandum may also be brought to the notice of the organizations under the administrative control of the Ministries/Departments which have adopted the Central Government scales of pay.
