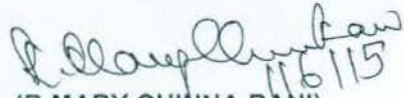

In exercise of the re-delegated financial powers cited vide reference 2nd cited, sanction of the undersigned is hereby accorded to incur an expenditure not exceeding ₹ 11,06,045/- (Rupees Eleven lakhs six thousand and forty five only) towards the grant of 75% subsidy on the annual premium paid by the registered mechanized fishing boat owners for insuring their boats against marine risks and as detailed in the Annexure enclosed for the years 2012-13 and 2014-15 under the Scheme of "Development of Marine Fisheries through Mechanization and Reimbursement of Sales Tax on HSD oil and Assistance to Small Scale Fishermen".

2. Permission is also accorded to release the above amount of ₹ 1106045/- (Rupees Eleven lakhs six thousand and forty five only) directly to the beneficiaries Saving bank A/c by way of ECS mode as per annexure.

The expenditure is debitable to the Head of Account, "2405-Fisheries-103 (05)-Development of Marine Fisheries through Mechanization and Reimbursement of Sales Tax on HSD oil and Assistance to small scale fishermen – 103 (05) (01)- Puducherry region (33)-Subsidy- Plan" in the budget of the current financial year.
