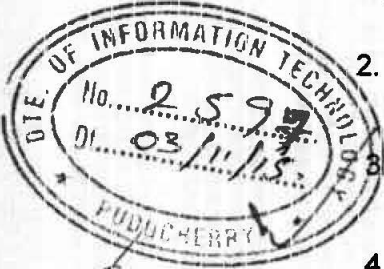

Whereas an amount of **Rs. 5,29,36,800/- (Rupees Five Crores twenty nine lakhs thirty six thousand and eight hundred only)** has so far been sanctioned under the Scheme "Old Age Pension for Fishermen" in two phases viz., **Rs.1,32,34,200/-** for the months from April 2015 to June 2015 vide Order 1st cited and for **Rs.3,97,02,600/-** for the months from July 2015 to March 2016 @ **Rs.1150/- per pensioner per month** vide G.O. 2nd cited.

Whereas, Notification for enhanced rates of Old Age Pension with effect from June, 2015 has been issued vide reference 3rd cited. The difference amount of **Rs.94,50,510 /-** was sanctioned as arrears for the months from June to August 2015 vide ref 4th cited.

Whereas, out of the amount so far sanctioned vide Order / G.O. under the various dates, an amount of **Rs.2,97,62,490/-** only has been booked towards the disbursement of Pension to the beneficiaries for the months from **April 2015 to August 2015 through ECS** and an amount of **Rs.2,46,30,510/-** is now available out of the amount sanctioned as detailed below:
