

In exercise of the re-delegated financial powers cited vide reference 2nd cited read with G.O. cited under reference 1st, sanction of the undersigned is hereby accorded to incur an additional expenditure not exceeding Rs.3,30,000/- (Rupees Three lakhs thirty thousand only) towards the reactivation charges to 18 Nos. of eligible applicants of the Steel/Wooden Mechanized and FRP Mechanized boats of Puducherry region during ban on Fishing for the year 2015-16 as second phase under the Scheme of "Development of Marine Fisheries through Mechanization and Reimbursement of Sales Tax on HSD oil and Assistance to Small Scale Fishermen", as tabulated below:-

i.	Financial grant of reactivation charges @ Rs.20,000/- to 15 nos. of steel/Wooden/FRP mechanized boat owners	Rs.3,00,000/-
ii.	Financial grant of reactivation charges @ Rs.10,000/- to 03 nos. FRP mechanized (inboard) boat owners.	Rs.30,000/-
Total		Rs.3,30,000/-

2. Permission of the undersigned is also accorded to release the above amount of Rs.3,30,000/- (Rupees Three lakhs thirty thousand only) directly to the beneficiaries Saving bank A/c by way of ECS mode as per annexure enclosed.
