

In exercise of the re-delegated financial powers vide reference 2nd cited read with G.O. under reference (1) above , sanction of the undersigned is hereby accorded to incur an expenditure not exceeding **Rs.12,60,000/- (Rupees Twelve lakhs sixty thousand only)** towards the reactivation charges to 68 Nos of eligible applicants of the Steel/Wooden Mechanized and FRP Mechanized boats of Puducherry region listed in the annexure during ban on Fishing for the year 2016-17 as first phase under the Scheme of "Development of Marine Fisheries through Mechanization and Reimbursement of Sales Tax on HSD oil and Assistance to Small Scale Fishermerl' along with permission to release the above amount of **Rs.12,60,000/- (Rupees Twelve lakhs sixty thousand only)** directly to the beneficiaries Saving bank A/c by way of ECS mode, as per annexure.
