In exercise of the re-delegated financial powers conferred vide reference 2<sup>nd</sup> cited, sanction of the undersigned is hereby accorded to incur an expenditure not exceeding **Rs. 47453/- (Rupees Forty seven thousand four hundred and fifty three only)** towards the grant of 75% subsidy on the annual premium paid by the registered mechanized fishing boat owners for insuring their boats against marine risks for the year 2017-18 as Phase-IV under the Scheme of “Development of Marine Fisheries through Mechanization and Reimbursement of Sales Tax on HSD oil and Assistance to Small Scale Fishermen” and as detailed in the Annexure enclosed.

2. Permission is also accorded to release the amount of **Rs. 47453/- (Rupees Forty seven thousand four hundred and fifty three only)** directly to the beneficiaries’ saving bank accounts by way of ECS mode as per annexure.

The expenditure is debit to the Head of Account, “2405-Fisheries-103 (05) - Development of Marine Fisheries through Mechanization and Reimbursement of Sales Tax on HSD oil and Assistance to small scale fishermen – 103 (05) (01) - Puducherry region (33)- Subsidy- Plan” in the budget of the current financial year.
