GUIDELINES FOR IMPLEMENTATION OF SCHEME COMPONENT - "GRANT OF CENTRAL FINANCIAL ASSISTANCE TO AQUACULTURE FARMERS OF UNION TERRITORY OF PUDUCHERRY FOR CONSTRUCTION OF NEW PONDS /TANKS AND FOR INPUT COST FOR THE INITIAL CROP ONLY" TO UNDERTAKE BRACKISHWATER FISH/SHRIMP CULTURE UNDER CENTRAL SECTOR SCHEME ON "BLUE REVOLUTION: INTEGRATED DEVELOPMENT AND MANAGEMENT OF FISHERIES"

1. Title Of The Scheme:-

- (a) This scheme may be called as "Grant of Central Financial Assistance to Aquaculture farmers of Union Territory of Puducherry for construction of new ponds/tanks and for input cost for the initial crop only to undertake Brackishwater Fish/Shrimp Culture".
- (b) It extends to the whole of the Union Territory of Puducherry.
- (c) It shall come into force from the date of its publication in the Official Gazette of Government of Puducherry.

2.Objective:-

The objective of the scheme is to increase overall fish/shrimp production of U.T. of Puducherry in a responsible and sustainable manner by promoting Brackish water fish/prawn culture in the brackishwater bodies of Union Territory of Puducherry to ensure food and nutritional security and also to generate employment and export earnings.

3. Scope:-

The scope of the scheme is to grant Central Financial Assistance by way of subsidy to aquaculture farmers towards cost of construction of new ponds/ tanks including construction of sluice gates, civil works for water supply and aeration appliances, etc., and for purchase of required inputs such as fish/shrimp seeds, manure, feed, etc., to undertake Brackishwater fish/shrimp culture in the brackish water bodies of Union Territory of Puducherry.

4. Implementing Organisation:-

5. Target Group:-

Government Organizations/Federations/Corporations/Agencies/Members of Co-operatives/Collectives and all resident individual beneficiaries/aquaculture farmers fulfilling the eligibility criteria.

7. Eligibility Criteria and Terms and Conditions:-

7.1. Scheme Component-I : Construction of New Ponds/Tanks:

- (a) 50% of the unit cost with a ceiling of Rs.3.50 lakhs per ha would be extended as central financial assistance while the balance 50% would be borne by the individual entrepreneur/applicant. The applicant should furnish a declaration for investing the balance 50% of the unit cost from own funds.
- (b) No funds will be provided for the land.
- (c) The constructed ponds/tanks should have a minimum water depth of 1.5 M.
- (d) The financial assistance will be restricted to a maximum area of 2 ha for individual beneficiary, 2 ha x number of members of cooperatives/collectives subject to viability of pond sizes and with a ceiling of 20 ha for group/collectives. In respect of Government organizations/Federations/Corporations/Agencies, etc., financial assistance for quantum of hectarage will be decided on case to case basis in consultation with the concerned applicant. The subsidy will be sanctioned only to the new aquaculture farms proposed to be constructed and registered with the Coastal Aquaculture Authority and not for the already constructed/existing ponds/tanks
- (e) The applicant should not have availed of subsidy for the same activity under any scheme or agency.
- (f) The applicant should be a continuous resident of Union Territory of Puducherry for the preceding 5 years
- (g) The applicant should possess own land or land leased out for a continuous period of not less than 10 years.
- (h) The barren land proposed for construction of new ponds/tanks should be registered with Coastal Aquaculture Authority, Govt. of India.
- (i) The applicant should provide documentary evidence of availability of requisite land free from all encumbrances and financial resources along with necessary clearances/permissions, etc., in the Detailed Project Report.
- (j) A Detailed Project Report(DPR)with detailed estimate based on the existing Puducherry Schedule of Rates(PSR) by giving details with Survey plan showing neighboring area, Engineering layout, Location plan with details of adjoining properties of the aquaculture farm proposed along with operational details, water intake and waste water treatment facility be prepared by a Registered Chartered Engineer/Govt.approved agencies viz.,MPEDA/RGCA and submitted along with the application.
- (k) The applicant should furnish a declaration that his willingness to take up brackishwater fish/shrimp culture on scientific lines strictly in accordance with the guidelines issued by the Coastal Aquaculture Authority, Govt. of India from time to time and for revolving the sale proceeds of the first crop towards the inputs for second year and onwards.

7.2. Scheme Component-II: Inputs cost for Brackishwater Fish/Shrimp culture:-

- (a) The input cost for Brackishwater fish/shrimp culture would be extended only for the initial crop only i.e., for the First year only to those farmers/beneficiaries who have newly constructed ponds/tanks under the scheme component mentioned at SI.No.7.1 above.
- (b) 50% of the unit cost with a ceiling of Rs.1.00 lakhs and Rs.1.50 lakhs per ha for Finfish culture and Culture of shrimp such as L. vannamei/P. monodon, etc., respectively would be extended as central financial assistance while the balance 50% would be borne by the individual entrepreneur/applicant. The applicant should furnish a declaration for investing the balance 50% of the unit cost from his own funds.
- (c) Procurement of seed should be from Registered Hatchery only.

8. Mode of Payment:-

All financial assistance/subsidies would be released to the beneficiaries through ECS mode only.

9. Application For Beneficiary Under The Scheme Component:-

The application in Form –I shall be collected from the Pondicherry State Fishermen Co-Operative Federation, Puducherry/ The Karaikal Fishermen Co-Operative Marketing Union Ltd., Karaikal/ The Assistant Director of Fisheries and Fishermen Welfare, Yanam of the respective regions. The filled in applications shall be submitted along with the supporting documents for eligibility conditions as mentioned in item no. 7 of this Guidelines and Detailed Project Report(DPR)prepared by the Registered Chartered Engineer/Govt. agencies., viz., MPEDA/RGCA within the prescribed period to the respective regional offices of Department of Fisheries and Fishermen Welfare. Submission of application in Form-I is enough for availing assistance for both the components.No separate application is required for availing financial assistance under the scheme component-II, i.e., for input cost. However, beneficiary is required to submit three sets of Report as mentioned in clause No 11.4 of this Guidelines.

Note:

For the purpose of release of input subsidy alone, the members of the Selection-cum-Monitoring Committee is restricted to three viz., Chairman (Director of Fisheries/Collector, Karaikal/Regional Administrator, Yanam), Representative from MPEDA and Member Secretary (DDF(BW)/DDF,KKL/ADF, Yanam) and for selection of beneficiaries and release of construction subsidy, the members of the above committee remain unaltered. The Chairman of the committee of the respective regions, if feels necessary, may co-opt any person/persons from any Govt. Organization/Organizations as member of the above committee.

11.Methodology Of Selection and Mode Of Implementation:-

- 11.1. Submission Of Application: The application in the prescribed Form-I for availing financial assistance under this scheme will be received only from the aquaculture farmers who owns vacant land or land leased out proposed for construction and duly registered with Coastal Aquaculture Authority, Govt. of India, as per guidelines issued from time to time.
- 11.2.Selection Procedure: The submitted applications will be verified, on the fulfillment of eligibility conditions, by the Inspector of Fisheries/Sub-Inspector of Fisheries/Village Level Fisheries Officer of the Department of Fisheries and Fishermen Welfare, Puducherry/Karaikal/Yanam and after conduct of field enquiry. recommend for Selection and to place before the Committee for Selection/Release of subsidies as the case may be. The recommended applications will thereafter placed before the Selection-cum-Monitoring Committee for review mandatory field visit and selection of beneficiaries. The Committee is empowered to select or reject or keep pending any of the application/applications received, with proper recorded reasons. Keeping in view of achieving the objectives of the scheme components, the decision of the Committee,in selection procedure and release of subsidies,is final, adhering to the statutory norms of the Govt, and Coastal Aquaculture Authority, Govt. of India. The Member Secretary will arrange to send the list of selected beneficiaries, along with the minutes of the Selection Committee to the Department of Fisheries and Fishermen Welfare, Puducherry for obtaining approval of the Government.After receipt of approval from the Govt., the Member Secretary will intimate to the beneficiaries in writing with timelines for completion of work. Then, the beneficiary should commence the construction activity of the ponds/tanks afresh only after receipt of selection order from the Department of Fisheries and Fishermen Welfare of the concerned regions.
- 11.3. Release of Construction subsidy: After completion of construction of new ponds/tanks in all aspects and after release of fish/shrimp seed for the first crop, the beneficiaries should prepare three sets of report (one original and two copies) in the prescribed format available in the Department of Fisheries and Fishermen Welfare and submit to the Department of Fisheries and Fishermen Welfare of the concerned regions along with requisite original bills / vouchers on the actual expenditure incurred for the construction activities and photographs of newly constructed ponds/tanks and a copy of the bill received from the registered seed hatchery towards purchase of fish/shrimp seed for claiming the construction subsidy. The Selection-cum-Monitoring committee after scrutiny of bills/vouchers produced

and after conduct of field inspection to ensure that construction of the farm is in line with DPR submitted by the applicant for selection and in line with the norms of Coastal Aquaculture Authority, Govt. of India, will recommend to the Department of Fisheries and Fishermen Welfare, Puducherry for release of financial assistance for completion of construction of New ponds/tanks alone.

- 11.4. Release of Input cost subsidy:- The beneficiaries after harvest of first crop should prepare three sets of report (one original and two copies)in the prescribed format available in the Department of Fisheries and Fishermen Welfare and submit to the Department of Fisheries and Fishermen Welfare of the concerned regions along with harvest details and its value, requisites original bills/vouchers towards purchase of seeds from the Registered Hatchery, feeds and other inputs for claiming subsidy for inputs cost. After scrutiny of bills/vouchers and the report on harvest details, the Selection-cum-Monitoring committee(restricted to three members only viz., Chairman(Director of Fisheries/Collector, Karaikal/Regional Administrator, Yanam), Representative from MPEDA and Member Secretary (DDF(BW)/DDF, KKL/ADF, Yanam)) will recommend to the Department of Fisheries and Fishermen Welfare, Puducherry for release of financial assistance towards input cost for the initial crop.
- 11.5. The Selection-cum-Monitoring committee, may at any time visit the construction activities of ponds/tanks by the beneficiaries and shall also monitor the progress of construction and subsequent farming phases.
- 12. All the conditions stipulated in the scheme guidelines issued by Govt. of India should be strictly followed without any deviation.

13. Interpretation And Clarification:-

If any doubt arises with regard to the interpretation of any of the provisions of this Scheme and implementation thereof, the matter shall be referred to the Secretary to Government(Fisheries), Puducherry whose decision thereon shall be final.
