**ORDER**

In exercise of the powers conferred vide reference 2<sup>nd</sup> cited, sanction of the Special Secretary to Government (Fisheries) is hereby accorded for incurring of an expenditure not exceeding ₹ 1,32,34,200/- (Rupees One crore thirty two lakhs thirty four thousand and two hundred only) towards the payment of Old Age Pension @ ₹ 1150/- per month to 3836 numbers of beneficiaries of the Puducherry region for a period of three months April 2015 to June 2015 under the scheme component "Old Age Pension for Fishermen" under the scheme "Welfare and Relief for fishermen during Natural Calamities" for the Financial year 2015-16.

2. The month wise details of amount sanctioned are as follows:

Sanction of the Special Secretary to Government (Fisheries) is also accorded to draw the amount of ₹ 44,11,400/- (Rupees forty four lakhs eleven thousand and four hundred only) month-wise as detailed in para 2, by the Deputy Director of Fisheries and Fishermen Welfare (Welfare), Puducherry to effect e-payment of Old Age Pension by presenting bills along with list of beneficiaries to the DAT, Puducherry every month.

4. The expenditure is debit to the Head of Account, "2405 – Fisheries – 800 – the Expenditure – 800 (04) – Welfare and Relief for Fishermen during Lean seasons and Natural calamities – 800 (04) (01) – Pondicherry Region – 50 – Other Charges – PLAN" in the vote on account 2015 – 16 wherein sufficient funds are made available.
