In exercise of powers conferred in the reference 2nd cited above, sanction of the Secretary to Government (Fisheries), Puducherry is hereby conveyed for incurring an expenditure not exceeding an amount of **Rs.6,43,500/-** (Rupees Six lakh forty three thousand and five hundred only) being the grant of 50% subsidy for purchase of 39 Nos. of FRP Non-motorized catamaran with net under the scheme, "Development of Marine Fisheries through Mechanization and Reimbursement of Sales Tax on HSD oil and Assistance to Small Scale Fishermen" for the year 2021-22 as per the annexure enclosed.

2. Permission is also accorded to draw the entire amount in advance sanctioned at para 1 above and release the amount to the Secretary, Puducherry State Fishermen Co-operative Federation Limited, for implementation.


