#### ORDER:

WHEREAS the Government had accorded an expenditure sanction of Rs.6,81,62,000/with permission to draw Rs.4,50,27,000/- only in advance vide G.O. dated 22.10.2013 first read above, as a first stage payment and for its disbursement by way of e-payment to the 555 numbers of beneficiaries and for depositing the same with one of the nationalized banks in Puducherry region.

WHEREAS in adherence to the above G.O., the department had released the first stage payment to 334 numbers of beneficiaries and single lumpsum payment to 207 numbers of beneficiaries. Out of Rs.4,50,27,000/- drawn, amount to the tune of Rs.4,45,95,000/- have been disbursed and the balance amount of Rs.4,32,000/- payable to 7 numbers of beneficiaries have been taken to Civil Deposit for further disbursement. An amount of Rs.21,28,43,355/- has been disbursed to beneficiaries under Thane Relief as against the total amount of Rs.22,68,98,355/- drawn through various G.O.s and the balance amount of Rs.1,40,55,000/has been credited to Civil Deposit departmental head for future disbursement as per the table below:
