ORDER:

Sanction of the Hon'ble Lieutenant Governor, Puducherry is hereby conveyed for the release of an amount not exceeding **₹.19,80,000/- (Rupees Nineteen Lakhs eighty thousand only)** to **1650** nos. of fisher subscribers of Yanam Region @ ₹.1200/- under Centrally Sponsored Scheme, "National Scheme of Welfare of Fishermen -- Savings cum Relief" for the year **2012-13** as 1st phase.

2. Sanction of the Hon'ble Lieutenant Governor is also conveyed to draw the entire amount sanctioned in para 1 in advance and deposit the same in A/C. No. 10831176317 maintained in State Bank of India, Puducherry of the Director of Fisheries maintained for the above scheme and to disburse the Government share of ₹.1200/- along with fishers' subscription of ₹.600/- to 1650 fishers of Yanam region, by ECS and adjustment bill has to be presented within one month from the date of drawal of the advance amount, along with the conditions as below:

"The details of payment to the beneficiaries viz. name of beneficiary, address, amount, date, etc. should be published in the official Website of the Department of Fisheries & Fishermen Welfare, Puducherry, for the information of the General Public".

3. The above sanction is subject to the condition that the Interest accrued from Bank Accounts shall be remitted into Govt. Account under the Head of account **"0049-Interest Receipts -- 904 -Interest Receipts of State / UT Governments -- 110 interest realised on Investment of cash balances"** as per Order No.10-1/FD(W&M)/2014 dated 11.07.2014 of FD(Ways & Means), Puducherry.

4. The above expenditure is debit to the Head of Account **"2405 -- Fisheries -- 800 Other Expenditure - 800 (02) Savings cum Relief for Marine Fishermen (CSS) -- 800 (02) (01) -- Puducherry Region -- (50) - Other charges - PLAN"** in the R.E. of 2014-15.
